BAC-I Resolution No. 2018 - 001

WHEREAS, the Bases Conversion and Development Authority (BCDA), has put on bid the **CONSTRUCTION OF FRONTHAUL OF THE CABLE NETWORK CORRIDOR FOR THE LUZON BYPASS INFRASTRUCTURE PROJECT LOCATED IN BALER, AURORA AND IN SAN FERNANDO, LA UNION** with an approved budget of Twenty Five Million Two Hundred Sixty Nine Thousand Five Hundred Seventy Five Pesos and 89/100 (Php25,269,575.89), inclusive of all applicable taxes and fees.

WHEREAS, the Bids and Awards Committee for Infrastructure (BAC-I), through its Secretariat, advertised the Invitation to Bid in a newspaper of nationwide circulation and posted the same in the BCDA website, PhilGEPS and in a conspicuous place reserved for the purpose in the premises of BCDA on 08 December 2017.

WHEREAS, in response to the Invitation to Bid, two prospective bidders purchased the bidding documents namely:

1. Globe Telecom; and
2. Converge ICT Solutions Inc.

WHEREAS, on the deadline for the submission of bids, on 08 January 2018, the two prospective bidders did not submit their bids.

WHEREAS, the BAC for Infrastructure declared a failure of bidding pursuant to Section 35.1 of the Revised IRR of RA 9184, viz;

35.1 The BAC shall declare the bidding a failure when:

- b) To endorse the bidding documents to the End-User for the conduct of a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates pursuant to Section 35 of the Revised IRR of RA 9184; and
- c) To proceed with the re-bidding of the **CONSTRUCTION OF FRONTHAUL OF THE CABLE NETWORK CORRIDOR FOR THE LUZON BYPASS INFRASTRUCTURE PROJECT LOCATED IN BALER, AURORA AND IN SAN FERNANDO, LA UNION** upon re-submission by the End-User of Bidding Documents.
