WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid THE RENTAL OF SIX (6) MONOCHROME AND TEN (10) COLORED MULTI-FUNCTION COPY MACHINES with an Approved Budget for the Contract (ABC) in the amount of Pesos: Two Million Four Hundred Thousand (Php2,400,000.00), inclusive of all applicable taxes and fees;

WHEREAS, the BAC-G, through its Secretariat, advertised the Invitation to Bid on 24 April 2017 in the following:

- a. Newspaper of nationwide circulation;
- b. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- c. BCDA Website;
- **d.** In a conspicuous place reserved for the purpose in the premises of BCDA;

and said Invitation to Bid was posted continuously for seven (7) calendar days in \underline{b} to \underline{d} ;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders purchased the bidding documents, namely: 1) Otus Copy Systems, Inc.; and, 2) UBIX Corporation;

WHEREAS, on the day of opening of bids on 19 May 2017 at 2:00 PM, the above-named two (2) bidders submitted their eligibility documents and were all found eligible, hence, their financial proposals were opened which were likewise found to be complying, as shown in the matrix below:

WHEREAS, based on the comparison of the above financial proposals of the two (2) bidders, **UBIX Corp**. submitted the Lowest Calculated Bid;

WHEREAS, on 25 May 2017, the Technical Working Group (TWG) conducted post qualification of UBIX Corp. to determine whether it complies with and is responsive to the requirements and conditions specified in the Bidding Documents; thereafter, the TWG recommended in its Report of Post-Qualification (hereto attached as Annex "B") to post-disqualify UBIX Corp. for its Non-Compliance with the Legal Requirements, citing the failure of UBIX Corp. to submit a valid Tax Clearance per E.O. 398, 2005; further, the TWG recommended to proceed with the post-qualification of the Second Lowest Calculated Bid:

Reference. Pursuant to the provisions in Section 34 of the Revised Implementing Rules and Regulations of RA 9184, the TWG of the BAC for Goods conducted a post qualification evaluation to determine whether **UBIX** complies with and is responsive to all the requirements and conditions specified in the bidding documents for the Bidding for the One(1) Year Rental of Six (6) Monochrome and Ten (10) Color-Multi-Function Machines for 2017.

The post qualification activity covered the following:

I. Verification of the documents submitted against the original

The documents submitted, as enumerated in the Checklist of Requirements, were verified against the original copies. Based on our evaluation, the documents submitted are in accordance with the requirements as they are true and faithful copies of the original documents presented during the conduct of the post qualification.

It is compliant with the minimum amount required for on-going and completed contracts within the prescribed period, starting April 2014 to April 2017, based on the list of on-going and completed contracts submitted; duly supported with copies of Purchase Orders, Notice of Awards, Notices to Proceed, Sales Invoices, and Official Receipt.

One of the documents presented related to the company's On-Going Projects is with the Philippine Health Insurance Corporation amounting to Three Million Three Hundred Seventy Five Thousand Seven Hundred Nine Pesos and Eighteen Centavos (\mathbb{P} 3,375,709.18).

They have also completed a contract with Bangko Sentral ng Pilipinas from September 9, 2013 to November 8, 2016 for the rental of one hundred fifty five (155) units monochrome multifunctional machines amounting P0.76/copy and seven (7) units colored multi-function machines amounting to amounting P4.50/copy.

*The eligible bidder did not comply with the required Legal documents (Tax Clearance).

III. Financial Requirement Compliance

UBIX Corporation was organized under the laws of the Republic of the Philippines and registered with SEC on November 9, 1973 (based on its Articles of Incorporation), with the primary purpose of engaging in general merchandising business, import, purchase, sale, lease of goods, wares, copying machines, business machines, and/or office machines, and other accessories, parts and supplies.

Upon validation, the computed NFCC of UBIX is Php 16,037,826,869.15.

Based on their Audited Financial Statement for 2016, the total assets of the company as of December 31, 2016 amounts to Php 2,311,148,988.00. The said declared amount of total assets is sufficient to settle its total liabilities amounting to Php 885,785,639.00.

On the overall, the company's posted assets of Php 2,311,148,988.00 is enough to support the requirements of the project.

*The eligible bidder have complied with the required financial requirements.





Reference. Pursuant to the provisions in Section 34 of the Revised Implementing Rules and Regulations of RA 9184, the TWG of the BAC for Goods conducted a post qualification evaluation to determine on May 29, 2017 whether **OTUS** complies with and is responsive to all the requirements and conditions specified in the bidding documents for the Bidding for the One (1) Year Rental of Six (6) Monochrome and Ten (10) Color Multi-Function Machines for 2017. This after the bidder with the Lowest Calculated Bid (UBIX Corporation) was post-disqualified due to its failure to submit a valid Tax Clearance as part of its Legal Document requirement.

On May 29, 2017 at 4:15 PM the TWG arrived at the company's office in Mandaluyong City to inspect the machine's functionalities, and to measure the dimensions of the offered unit. During the conduct of the post qualification activity, the TWG Members took note of the following:

1. According to Mr. Erwin C. Manarpis, OTUS President and Chairman, instead of deploying Six (6) Monochrome and Ten (10) Color Multi-Function Copy Machines, all machines to be deployed shall be Color Multi-Function Copy Machines. Six machines intended for monochrome printing will be restricted

for such type of printing. Admin access shall be given to BCDA to allow color print/copy in the event that BCDA needs the said functionality.

- 2. The multi-function copy machine presented is compact. If deployed in BCDA, it will occupy smaller space;
- 3. The machine has very minimal possibility of paper jams based on the design of the machine. Per demonstration, the demo machine accepted for printing crumpled and torn paper despite the poor quality of paper supply; and,
- 4. Machine will still function despite incomplete toner.
 - e.g. Monochrome print requirement will still be processed by the machine even if a color toner is low or unavailable.

Among the technical requirements that were found compliant with OTUS' demo machine, the TWG members failed to check the functionality of the Finisher due to lack of time and unavailability of the said component in their office.

Due to this, another testing was conducted on May 31, 2017 in the OTUS Warehouse at Pasig City where the unit with Finisher was located.

As a result of the Post Qualification activities conducted with OTUS Copy Systems, Inc., the TWG certifies that the machine's functionalities and dimension comply with the requirements stated in the Terms of Reference for this procurement. Attached are test prints conducted showing vividness of colored printing.

Based on the inspection conducted, the TWG certifies that OTUS Copy Systems is compliant with all the technical specifications required by BCDA.

III. Financial Requirement Compliance

OTUS COPY SYSTEMS, INC. was incorporated and registered with the Philippine Securities and Exchange Commission (SEC) on May 3, 2006 under SEC Registration No. CS200606472. The Company was organized primarily to engage in the business of trading goods such as photocopiers, consumable, parts on wholesale/retail.

Based on their Audited Financial Statement as at and for the year ended December 31, 2016, the total assets of the company as of December 31, 2016 in the amount of Php15,216,343.00 is sufficient to settle its total liabilities amounting to Php166,712.00

The computation below shows the Liquidity of OTUS COPY SYSTEMS, INC.

A current ratio that is better than 1 to 1 is considered good. The higher the ratio, the better the financial position of the company. The current ratio of **OTUS COPY SYSTEMS**, **INC**. is 70.97 to 1, it indicates they are in a sound financial position,
