DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

**CONSTRUCTION AND MANAGEMENT SUPERVISION FOR THE NEW CLARK CITY (NCC) TO
SUBIC-CLARK-TARLAC EXPRESSWAY (SCTEX) ACCESS ROAD**

WHEREAS, the procurement for the above subject was approved by the BCDA Board on 18 December 2017 with an Approved Budget for the Contract (ABC) amounting to **Pesos: One Hundred Million Five Hundred Fifty Five Thousand and 00/100 Pesos (PhP 100,555,000.00)**, inclusive of all applicable taxes and fees, to be completed within twenty four (24) months;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure, wherein the technical and financial proposals shall be given a corresponding weight of 85% and 15%, respectively. The consultant must pass the required 70% minimum score;

WHEREAS, on 23 April 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in BCDA website, PhilGEPS and in conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, the following firms responded and secured Eligibility Documents for the above services:

- a. Design Science Incorporated
- b. Joint Venture between Foresight Development & Surveying Company and Ernesto S. De Castro Associates, Inc.
- c. Pertconsult International
- d. Joint Venture between DCCD Engineering Corporation and Katahira & Engineers International
- e. TCGI Engineers;

WHEREAS, the above proponents submitted their accomplished eligibility documents before the deadline of submission on 10 May 2018, 8:30am;

WHEREAS, on the same day, at 9:00am, the accomplished eligibility documents of the five (5) proponents were opened based on the non-discretionary "pass/fail" criterion.

WHEREAS, the five (5) proponents passed the Eligibility Check thus and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted technical documents are as follows:

3. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings.
