

What is the minimum qualification for joint ventures?	Pursuant to Section 13 (Qualification of Bidders) of the Terms of Reference of the Bidding Documents, to wit:			
	13.2 "In case of Joint Venture (JV) , at least one of the JV partners should be a reputable firm with at least five (5) years of business operation, provided further that the member with at least five (5) years of business operation must be designated as the lead of the JV.			
	13.3. The Consultant should have undertaken at least one (1) Construction Management & Supervision of building project with a contract amount of Php7,254,240.00. In case of a JV, at least one of the members of the JV should have experience in handling at least one construction management of building project with contract amount at least of Php7,254,240.00, provided further that the member that has the experience of handling the construction management project with a contract amount of at least Php7,254,240.00 must be designated as the lead of the JV."			
Do we need to submit Curriculum Vitaes (CVs) of the support staff?	No. Only the key personnel are required to submit CVs. They also need to submit supporting documents like

	the photocopy of renewed and/or valid PRC licenses, training certificates, etc. for validation purposes.
	However, for the Support Staff (1 architect, 1 QA/QC Inspector, 1 Quantity Surveyor, 1 Engineer), their curriculum vitae together with the necessary supporting documents shall be presented by the bidder and verified by the SBAC for NAS during the post qualification process.
Is there another schedule for the site inspection?	No. There is only one schedule for the site inspection.
	Although we encourage the bidders to be present during the site inspection, it is not a requirement for this bidding.





Section 28.3 Post Qualification of the Instructions to Bidders (ITB)

28.3. The determination shall be based upon examination ofdocumentary evidence of the Consultant's qualifications submitted pursuant to ITB Clauses 10 and 11, as well as other information as the Procuring Entity deems necessary and appropriate, using a non-discretionary "pass/fail" criterion, which shall be completed within a period of twelve (12) calendar days.

Section 28.3 Post Qualification of the Instructions to Bidders (ITB)

28.3. The determination shall be based upon an examination ofdocumentary evidence of the Consultant's qualifications submitted pursuant to ITB Clauses 10 and 11, as well as other information as the Procuring Entity deems necessary and appropriate, using a non-discretionary "pass/fail" criterion, which shall be completed within a period of twelve (12) calendar days. Additional requirement in the post qualifications is the submission of Curriculum Vitae of the required Professional Support Staff and should be supported licenses/ professional registrations, for expired licenses, copy of the expired license, proof of application and payment for renewal should be included.

For clarity purposes, we will attach the bidding forms *(see Annex A)* required for the submission of eligibility documents, technical, and financial components.

Amendments made herein shall be considered an integral part of the Bidding Documents.
