BID BULLETIN NO. 13

TO ALL PROSPECTIVE PRIVATE SECTOR PARTICIPANTS:

This Bid Bulletin No. 13 is being issued to amend, revise, modify, supplement, and clarify the Invitation Documents for the Competitive Selection for the Joint Venture Development of the Water and Wastewater Infrastructure Project in New Clark City (the "Project").

Capitalized terms used and not otherwise defined in this Bid Bulletin No. 13 shall have the meaning given to them in the Instructions to Private Sector Participants ("IPSP"): Volume 2 – Competitive Selection Documents relating to the Project issued by the Joint Venture Selection Committee of the Bases Conversion and Development Authority for the Project on 30 July 2018.

In accordance with Section 3.2 of IPSP: Volume 2 — Competitive Selection Documents, this Bid Bulletin No. 13 is issued to all Provisionally-Eligible PSPs / Eligible PSPs who purchased (or for a Consortium, whose Consortium Member purchased) the IPSP: Volume 1 – Forms and Annexures and is automatically incorporated into and made an integral part of the particular document to which it relates.

A. Revised Timeline

All Provisionally-Eligible PSPs / Eligible PSPs are further advised that:

- (a) **25 October 2018 at 9:00 a.m.** shall (as an amendment of the date previously indicated as 25 September 2018 at 9:00 a.m.) be the Proposals Submission Date. Section 10 of IPSP: Volume 2 — Competitive Selection Documents is accordingly modified to reflect such date and time.
- (b) **25 October 2018 at 9:30 a.m.** shall (as an amendment of the date previously indicated as 25 September 2018 at 9:30 a.m.) be the date and time for the opening of the Technical Proposal. Section 9.6(d) of IPSP: Volume 2 —

Competitive Selection Documents is accordingly modified to reflect such date and time.

- (c) **18 October 2018**, which is the date that is seven (7) days prior to the revised Proposals Submission Date, shall be the Post-Eligibility Documents Submission Date in accordance with IPSP: Volume 1 – Eligibility Documents.
