Please be informed of the following clarifications based on discussions during the Pre-Bid Conference held last 15 December 2017. This Bid Bulletin shall form part of the bidding documents.

Questions/Queries	Clarifications
<p>1. Will the amount of the Financial Proposal have a bearing on the hierarchy level of Bidders that were ranked based on their Technical Proposals?</p>	<p>No, the Financial Proposal has no bearing on the results of the Quality-Based Evaluation (QBE) of Technical Proposals.</p> <p>However, if the Financial Proposal is beyond the Approved Budget of the Contract (ABC), the concerned bidder shall be disqualified, regardless of ranking.</p>
<p>2. Since BCDA is a government entity, is the project tax exempt?</p>	<p>No. The amount of the Financial Proposal shall be inclusive of all applicable taxes and fees.</p> <p><i>(Sec. 11.5, Bid Data Sheet of the Bidding Documents)</i></p>
<p>3. Can we replace the key personnel that was initially endorsed during Eligibility Stage of the Bidding?</p>	<p>Yes.</p> <p>Please note, however, that under Section 33.3 of the revised IRR of RA 9184, There should be no replacement of key personnel before the awarding of contract, except for justifiable reason as may be acceptable to the BAC, such as, illness, death, or resignation provided it is duly supported by relevant certificates.</p>
<p>4. Can we add personnel in the list?</p>	<p>Yes, but this will not be an additional score for the bidder. Further, "Aside from the main members of the Creative Team, the Firm shall provide all other support staff and production crew necessary for the completion of all requirements for this project at no additional cost to BCDA."</p> <p><i>(3<sup>rd</sup> Par., Sec. 5 Terms of Reference)</i></p>


The clarifications herein issued effectively amend, modify or revise provisions of the TOR and bidding documents which are inconsistent or contradictory thereto.
