B. Question/Query

1. On criterion item 3(b) for Eligibility Shortlisting stage shown above:

Does R.A. No. 9184 allow the deviation from clause 24.5.3(b) "qualification savs. personnel who may be assigned to iob" and change "qualification of personnel to be assigned"; and

There is no deviation from clause 24.5.3

Section 24.5.3 of RIRR of R.A. No. 9184 provides that:

"xxx"

b) Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking;

xxx"

The published eligibility criteria for shortlisting in the Bidding Documents provides that, "xxx Qualification of Personnel to be assigned xxx".

This should not be considered as a deviation from the eligibility requirements prescribed by the RIRR of R.A. No. 9184. In evaluating the bidders' submissions, we refer to Section 33.3 of the RIRR of R.A. No. 9184 which provides:

"There should be no replacement of key personnel before the awarding contract, except for justifiable reasons as may be determined by the BAC, such as, illness, death, or resignation provided it is duly supported by relevant certificates, or any delay caused by the Procuring Entity. xxx"

Nonetheless, the observation stands and the eligibility criteria shall be revised in accordance with Section 24.5.3, subject

Does this mean that for the Shortlisted Consultants, they are only to prepare and complete the Plan Approach of Methodology (20.00% rating) in the Bidding Stage because the first two criteria for evaluation (80.00 % rating) were already evaluated under the Eligibility Stage, and that there is no way to improve the bid proposal for the criterion on Qualification of Personnel (60% rating)?

to Section 33.3. Please refer to Clause II of this Bid Bulletin.

No. Bidders shall submit all the Bidding Stage requirements specified in the Bidding Documents. The RIRR of R.A. No. 9184 is clear on the criteria for Shortlisting, and Evaluation of Technical Proposals. For shortlisting of bidders, Section 24.5.3 provides that:

24.5.3 The BAC shall specify in the Request for Expression of Interest the set of criteria and rating system for short listing of consultants to be used for the particular contract to be bid, which shall consider the following, among others:

- Applicable experience consultant and members in case of joint ventures, considering both the overall experiences of the firm or, in the case of new firms, the individual experiences of the principal and key staff, including the times when employed by other consultants;
- b) Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking; and
- c) Current workload relative to capacity.

For the evaluation of technical proposal, Section 33.2.2 provides that:

"33.2.2 The technical proposals of consultants shall be evaluated based on the following criteria and using the corresponding numerical weights indicated in the Bidding Documents:

- a) Quality of personnel to be assigned to the project which covers suitability of key staff to perform the duties of the particular assignments and general qualifications and competence including education and training of the key staff;
- b) Experience and capability of the consultant which include records of previous engagement and quality of performance in similar and in other projects; relationship with previous and current clients; and, overall commitments, geographical distribution current/impending projects attention to be given by the consultant. The experience of the consultant to the project shall consider both the overall experiences of the firm and the individual experiences of the principal and key staff including the times when employed by other consultants; and
- c) Plan of approach and methodology with emphasis on the clarity, feasibility, innovativeness and comprehensiveness of the plan approach, and the quality of interpretation of project problems, risks, and suggested solutions.

For complex or unique undertakings, those involving such concepts/technology or financial advisory participating services, shortlisted consultants may be required, at the option of the agency concerned, to make an oral presentation to be presented by each consultant, or its nominated Project Manager or head, in case of firms, within fifteen (15) calendar days after the deadline for submission of technical proposals."

These requirements arise from Sections 24 and 33 of RIRR of R.A. No. 9184 are

For expired licenses, copy of the expired license, proof of application and payment for renewal shall be included.

- 4. Only contracts/projects that are supported with proofs shall be considered for evaluation, as follows:
 - Certificate of Completion or Acceptance or valid proof of final payment issued by the client, in case of completed contracts.
 - Notice of Award, Notice to Proceed or signed contracts issued by the client for ongoing contracts and for contracts awarded but not yet started.
- 5. Only training supported with proofs shall be considered for evaluation.


