
The above schedule accordingly amends the schedule on the PhilGEPS and BCDA websites.

For Online Participants:

- 1. Online participants are requested to register by sending an email to the SBAC Secretariat at sbac_sec_nasp2@bcda.gov.ph, before the conference, for documentation purposes and to be admitted on the call.
