**TO ALL PROSPECTIVE PRIVATE SECTOR PARTICIPANTS:**

Capitalised terms used and not otherwise defined in this Bid Bulletin No. 7 shall have the meaning given to them in the Instructions to Private Sector Participants: Volume 1 - Eligibility Documents issued by the Joint Venture Selection Committee of the Bases Conversion and Development Authority on 16 May 2018, as amended through Bid Bulletin No. 5, for the Competitive Selection for the Joint Venture Development of the Electric Power Distribution System in New Clark City.

This Bid Bulletin No. 7 is being issued to inform all prospective PSPs that:

1. **18 July 2018 at 9:00 a.m. Philippine Standard Time (PST)** shall (as an amendment of the date previously indicated as 3 July 2018 at 9:00 a.m. on Bid Bulletin No. 5) be the **Eligibility Documents Submission Date**. Section 8 of IPSP: Volume 1 — Eligibility Documents is accordingly modified to reflect such date and time.
2. **18 July 2018 at 9:30 a.m. PST** shall (as an amendment of the date previously indicated as 3 July 2018 at 9:30 a.m. on Bid Bulletin No. 5) be the **Date of Opening of Eligibility Documents**. Sections 7.4(e) and 11.1 of IPSP: Volume 1 — Eligibility Documents are accordingly modified to reflect such date and time.

In consideration of the on-going discussions to resolve the regulatory issues on the Project, and to reflect the results of these discussions in the Joint Venture Agreement, the foregoing modifications have been approved by the JVSC.

In accordance with Section 2.3 of IPSP: Volume 1 — Eligibility Documents, this Bid Bulletin No. 7 is issued and made available to all parties who purchased IPSP: Volume 1 – Forms and Annexures.

If any one of the provisions of this Bid Bulletin No. 7 is held invalid, illegal or unenforceable, the validity, legality or enforceability of the remaining provisions will not be affected thereby.
