TO ALL PROSPECTIVE PRIVATE SECTOR PARTICIPANTS:

This Bid Bulletin No. 9 is being issued to amend and modify the Invitation Documents for the Competitive Selection for the Joint Venture Development of the Water and Wastewater Infrastructure Project in New Clark City (the "Project").

Capitalized terms used and not otherwise defined in this Bid Bulletin No. 9 shall have the meaning given to them in the Instructions to Private Sector Participants ("IPSP"): Volume 1 -Eligibility Documents relating to the Project issued by the Joint Venture Selection Committee of the Bases Conversion and Development Authority for the Project, as amended.

This Bid Bulletin No. 9 is being issued to inform all prospective private sector participants of that:

- A. Amendment of Eligibility Documents Submission Date and Opening of Eligibility **Documents**
- 1. 16 July 2018 at 9:00 a.m. shall (as an amendment of the date previously indicated as 9 July 2018 at 9:00 a.m.) be the date of Eligibility Documents Submission Date. Section 8 of IPSP: Volume 1 - Eligibility Documents is accordingly modified to reflect such date and time.
- 2. 16 July 2018 at 9:30 a.m. shall (as an amendment of the date previously indicated as 9 July 2018 at 9:30 a.m.) be the date of opening of Eligibility Documents. Sections 7.4(e) and 11.1 of IPSP: Volume 1 - Eligibility Documents are accordingly modified to reflect such date and time.

In consideration of the nature and scope of the Project, the foregoing modification has been approved by the JVSC to provide prospective private sector participants additional time to evaluate the Eligibility Requirements and complete their Eligibility Documents and discussions on regulatory matters pursuant to the principles of competition and fairness.

B. Amendment of Definition of "PSP Industry Affiliates" as Specified in Section 1.2 of **IPSP: Volume 1 - Eligibility Documents**

The definition of "PSP Industry Affiliates" is revised to mean "all Affiliates of the Consortium Members engaged in the water and/or wastewater utilities in the Philippines." Section 1.2 of IPSP: Volume 1 – Eligibility Documents is accordingly modified to reflect such change.
