**WHEREAS**, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has bid out the Procurement of Fit Out, Repair, Supply, and Delivery of Office Furniture and Equipment for the Subic-Clark Railway Project Management Office with the following Approved Budgets for the Contracts (ABC), inclusive of all applicable taxes and fees:

**WHEREAS**, the BAC for Goods (BAC-G), through its Secretariat, posted the Invitation to Bid on 23 November 2019 in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, in response hereto, the following five (5) proponents submitted their bids for the following specific lot/s:

**WHEREAS**, there were no bids received for Lot A, Lot E, and Lot G.

**WHEREAS**, during the Opening of Bids on 16 December 2019, BAC-G received and opened the eligibility documents submitted by the proponents and were found compliant and were declared eligible for the opening of their financial proposals.

**WHEREAS**, after preliminary evaluation of the submitted bids by the BAC-G, **Contract Design and Systems Furniture Specialist, Inc.** passed and was declared as the **Single Calculated Bid for Lot B**; **Integrated Computer Systems, Inc.** passed and was declared as the **Single Calculated Bid for Lot C**; **Pronet Systems Integrated Network Solution, Inc.** passed and was declared **Lowest Calculated Bid for Lot D**; and **CT Link Systems, Inc.** passed and declared **Single Calculated Bid for Lot F**. *The Abstract of Bids is hereby attached as "Annex "A".*

**WHEREAS**, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted Post-Qualification on 18-20 December 2019 to determine if these companies: 1) Contract Design and Systems Furniture Specialist, Inc.; 2) Integrated Computer Systems, Inc.; 3) Pronet Systems Integrated Network Solution, Inc.; and 4) CT Link Systems, Inc., are compliant and responsive to the requirements and conditions specified in the Bidding Documents.

**WHEREAS**, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by Contract Design and Systems Furniture Specialist, Inc., Integrated Computer Systems, Inc., Pronet Systems Integrated Network Solution, Inc., and CT Link Systems, Inc., their respective bids

have been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B".*

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare **Contract Design and Systems Furniture Specialist, Inc.** as the Single Calculated and Responsive Bidder for **Lot B** in the amount of One Million Four Hundred Ninety-Nine Thousand Nine Hundred Seventy-Two Pesos and 10/100 (**Php1,499,972.10**), inclusive of all applicable taxes and fees;
2. To declare **Integrated Computer Systems, Inc.** as the Single Calculated and Responsive Bidder for **Lot C** in the amount of Two Million Seven Hundred Twenty-Four Thousand Eight Hundred Fifty-Nine Pesos (**Php2,724,859.00**), inclusive of all applicable taxes and fees;
3. To declare **Pronet Systems Integrated Network Solution, Inc.** as the bidder with the Lowest Calculated and Responsive Bid for **Lot D** in the amount of Two Million Six Hundred Sixteen Thousand Five Hundred Six Pesos (**Php2,616,506.00**), inclusive of all applicable taxes and fees;
4. To declare **CT Link Systems, Inc.** as the Single Calculated and Responsive Bidder for **Lot F** in the amount of One Hundred Ninety-Three Thousand Five Hundred Pesos (**Php193,500.00**), inclusive of all applicable taxes and fees;
5. To issue the Notices of Award to 1) Contract Design and Systems Furniture Specialist, Inc. 2) Integrated Computer Systems, Inc., 3) Pronet Systems Integrated Network Solution, Inc., and 4) CT Link Systems, Inc. (*copy attached*);
6. To direct the End-user unit to furnish the BAC-G copies of the duly conformed Notices of Award, Notices to Proceed and the duly executed agreements/contracts;
7. To declare failure of bidding for Lots A, E, & G;
8. To recommend to the End-User to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates of Lot A, Lot E, and Lot G, pursuant to Section 35.2 of the Revised IRR of RA 9184; and
9. To proceed with the re-bidding of Lot A, Lot E, and Lot G of the Procurement of Fit Out, Repair, Supply, and Delivery of Office Furniture and Equipment for the Subic-Clark Railway Project Management Office, pursuant to Section 35.3 of the Revised IRR of RA 9184.
