RESOLUTION OF AWARD (RESO NO. BG2019-018)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) bid out the Procurement of Various Dental Equipment with an Approved Budget for the Contract (ABC) of *One Million Six Hundred Fifty Two Thousand Pesos & 00/100 (PhP1,652,000.00)*, inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Goods, through its Secretariat, posted the Invitation to Bid on 08 October 2019 in the following:

- DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA

WHEREAS, in response to said invitation, only one (1) company, Invictus Dental Supplies Trading submitted its bid.

WHEREAS, on 25 October 2019, and during the scheduled Opening of Bids, the BAC for Goods received one (1) proposal from the lone bidder. During this event, said bidder submitted the required eligibility documents, the participating bidder was found eligible, thus, its financial proposal was opened.

WHEREAS, after the preliminary evaluation of the submitted documents by the BAC for Goods, Invictus Dental Supplies Trading passed and was declared the Single Calculated Bid in the amount of *One Million Six Hundred Forty Seven Thousand Pesos & 00/100* (PhP1,647,000.00), inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as "Annex "A"*.

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 28-29 October to determine whether Invictus Dental Supplies Trading is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by Invictus Dental Supplies Trading, its bid has been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B"*.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:
