TERMS OF REFERENCE (TOR)

III. Qualifications of Supplier:

- B. Must have completed at least a single similar project in the past three (3) years, with an amount of at least 50% of the proposed project.
- C. Must be able to provide a reliable and prompt after sales services. In this regard, bidders will issue a Certificate that they will provide reliable and prompt after sales services, if awarded the Contract for the Supply of one (1) set of Panoramic X-Ray Machine.

IV. Delivery Schedule:

- A. Procured items shall be delivered within thirty (30) days upon issuance of the Purchase Order/Notice to Proceed.
- B. Replacement of all items found to be defective and/or not in consonance with the specifications shall be made within one (1) week after the notification and turnover of the defective items.

V. Performance Security:

- A. To guarantee the faithful performance by the supplier of its obligations, it shall post a performance security within a maximum period of ten (10) calendar days from the receipt of the Notice of Award from the Procuring Entity. The performance security shall be valid until issuance of the final Certificate of Acceptance by the BCDA.
- B. The performance security shall be denominated in Philippine Pesos and posted in favor of the Procuring Entity in an amount equal to the percentage of the total bid price in accordance with the following schedule:

- A. The Supplier may bill BCDA after the delivery and acceptance of the materials with an amount equivalent to the price of the supplies delivered, subject to paragraph VI (b) above. Ten Percent (10%) of the total amount shall be retained and that full payment of the contract price shall be made only upon issuance of Certificate of Satisfactory Delivery of all the items required.
- B. The amount in Pesos shall be inclusive of all applicable taxes and fees to be paid to the government.

VII. Corrupt, Fraudulent, Collusive and Coercive Practices:

"Any attempt by a bidder to influence the Procurement Department or its authorized representatives in the evaluation of the bids or contract award decisions shall result in the rejection of its bid or revocation of award as the case may be, and the application of other sanctions and remedies provided by law".
