**Procurement of Manpower Services for General Support and Janitorial Services for BCDA under a Three (3)-Year Service Contract**

**RESOLUTION No. BG-2023-014**

**WHEREAS**, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the Corporate Operating Budget and 2023 General Appropriations Act (GAA), intends to apply the sum of **TWENTY-SEVEN MILLION EIGHT HUNDRED SEVENTY-FOUR THOUSAND NINE HUNDRED THIRTY-NINE PESOS AND 20/100 (PhP 27,874,939.20)**, inclusive of VAT and all other applicable government taxes, fees, and charges, being the Approved Budget for the Contract (ABC) **for the first year only**, to payments under contract for the bidding of **Manpower Services for General Support and Janitorial Services for BCDA under a Three (3)-Year Service Contract**, broken down as follows:

**WHEREAS**, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 19 April 2023 (Wednesday) in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, the BAC-G conducted the Pre-bid Conference on 26 April 2023 (Wednesday) at 9:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City which was attended by two (2) prospective bidders, to wit:

- a. DBP Service Corporation; and
- b. Omniworx Inc.

**WHEREAS**, in response to said advertisements, two (2) bidders, **DBP Service Corporation (DBPSC) and Omniworx Inc.** submitted their bids for the project before the deadline on 08 May 2023 (Monday) at 9:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

**WHEREAS**, during the 08 May 2023 (Monday) opening of bids at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G received and opened the bid from the above-mentioned bidders and noted the following:

**WHEREAS**, on 09 to 15 May 2023 the TWG conducted the Detailed Bid Evaluation and noted the following:

- A. The financial bid of DBP Service Corporation is Ineligible due to incomplete submission of the required supplies, tools and equipment and its corresponding amount, 31 items are missing out of 54 required items. Thus, the BAC-G declares DBP Service Corporation is Ineligible for the project; and
- B. There was a computational error on the submitted financial bid of **Omniworx Inc.** with a variance of **Php3,165,003.80**, as shown in the table below:

**WHEREAS**, after the deliberation by the BAC-G on the TWG Detailed Bid Evaluation Report, the bid of Omniworx Inc. was declared as the Lowest Calculated Bid;

**WHEREAS**, pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of **Omniworx Inc.** on 16-23 May 2023 to determine if **Omniworx Inc.** is compliant and responsive to the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, on 26 May 2023 (Friday) BAC-G deliberated on the result of the post-qualification and found that **Omniworx, Inc.** is compliant with all of the requirements of this project;

**WHEREAS**, the submitted bid price by **Omniworx, Inc.** in the amount of Php 23,776,434.40 is lower than the calculated bid price amounting to Php 26,941,437.20. Pursuant to Section 34.4 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, which states that;

*“If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower”.*

**ACCORDINGLY**, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare **Omniworx, Inc.** as the **Lowest Calculated and Responsive Bidder (LCRB)** for the **Procurement of Manpower Services for General Support and Janitorial Services for BCDA under a Three (3)-Year Service Contract**;
2. To award the contract to **Omniworx, Inc.** with the amount of **TWENTY THREE MILLION SEVEN HUNDRED SEVENTY-SIX THOUSAND FOUR HUNDRED THIRTY-FOUR PESOS AND 40/100 (Php23,776,434.40)**, inclusive of VAT and all applicable government taxes and fees; and
3. To direct the **Human Resources Management Department (HRMD)**, being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
