## RESOLUTION OF AWARD (RESO NO. BG2018-021)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Procurement of Audio and Video System for BCDA Clark Extension Office 2018 with an Approved Budget for the Contract (ABC) of Seventeen Million Eight Hundred Fifty-Two Thousand Pesos (Php 17,852,000.00), inclusive of all applicable taxes and fees.

**WHEREAS**, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 17 July 2018 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS):
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA

WHEREAS, in response to said advertisements, two (2) prospective bidders bought the bid documents for both Lots, namely, Audio-Video Solutions Corporation (A-V Solutions) and All Visual & Lights System.

**WHEREAS**, on 09 August 2018, on the scheduled Opening of Bids, the BAC for Goods received two (2) proposals from both above-mentioned bidders. During this event, both bidders having submitted the required eligibility documents were found eligible, thus, their financial proposals were opened.

WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, A-V Solutions passed and was declared the Lowest Calculated Bid in the amount of Twelve Million Seven Hundred Thousand & 00/100 (Php12,700,000.00), inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as "Annex "A"* 

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on two separate dates, 17 & 20 August 2018 to determine whether A-V Solutions is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by A-V Solutions, its bid has been found Complying and Responsive. The Post-Qualification Report is hereby attached as Annex "B".

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare **AUDIO-VIDEO SOLUTIONS CORPORATION** as the bidder with the Lowest Calculated and Responsive Bid for the BIDDING FOR THE PROCUREMENT OF AUDIO AND VIDEO SYSTEM FOR BCDA CLARK EXTENSION OFFICE 2018;

- 4. To direct the Information and Communications Technology Department, being the end-user, to furnish the BAC for Goods of copies of the duly conformed to Notice of Award, Notices to Proceed and the duly executed contract agreement.
