**REBIDDING FOR THE SUPPLY AND DELIVERY  
OF FIVE-ROOM PREFABRICATED BARRACKS**

**RESOLUTION NO. BG 2019-012**

**WHEREAS**, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) through its Corporate Operating Budget for 2019 has put on bid the **REBIDDING FOR THE SUPPLY AND DELIVERY OF FIVE-ROOM PREFABRICATED BARRACKS** with an Approved Budget for the Contract (ABC) in the amount of **One Million Eight Hundred Thousand Pesos (Php1,800,000.00)**, inclusive of all applicable taxes and fees;

**WHEREAS**, the BAC-G, through its Secretariat, advertised the Invitation to Bid on 16 August 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, given the said advertisements, no prospective bidder purchased the bidding documents and no bid was received by BCDA on 02 September 2019 at 10:00AM, the deadline for the submission of bids.

**WHEREAS**, the BAC-G declared failure of bidding pursuant to Section 35.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, *to wit*:

- 35.1 *The BAC shall declare the bidding a failure when:*
- a. **No bids are received;** (emphasis supplied)
  - b. *Xxx.*

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby resolved, to:

- 1) Declare **FAILURE OF BIDDING** for the Rebidding for the Supply and Delivery of Five-Room Prefabricated Barracks;
- 2) Direct end-user to conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents pursuant to Section 35 of the Revised Implementing Rules and Regulations of Republic Act No. 9184; and,
- 3) Recommend the Negotiated Procurement for the Supply and Delivery of Five-Room Prefabricated Barracks upon endorsement by the end-user to the BAC-G after aforesaid mandatory review.
