REBIDDING FOR THE SUPPLY AND DELIVERY OF FIVE-ROOM PREFABRICATED BARRACKS

RESOLUTION NO. BG 2019-012

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) through its Corporate Operating Budget for 2019 has put on bid the REBIDDING FOR THE SUPPLY AND DELIVERY OF FIVE-ROOM PREFABRICATED BARRACKS with an Approved Budget for the Contract (ABC) in the amount of One Million Eight Hundred Thousand Pesos (Php1,800,000.00), inclusive of all applicable taxes and fees;

WHEREAS, the BAC-G, through its Secretariat, advertised the Invitation to Bid on 16 August 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- **c.** In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, given the said advertisements, no prospective bidder purchased the bidding documents and no bid was received by BCDA on 02 September 2019 at 10:00AM, the deadline for the submission of bids.

WHEREAS, the BAC-G declared failure of bidding pursuant to Section 35.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, *to wit*:

35.1 The BAC shall declare the bidding a failure when: a. No bids are received; (emphasis supplied) b. Xxx.

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby resolved, to:

- 1) Declare **FAILURE OF BIDDING** for the Rebidding for the Supply and Delivery of Five-Room Prefabricated Barracks;
- Direct end-user to conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents pursuant to Section 35 of the Revised Implementing Rules and Regulations of Republic Act No. 9184; and,
- 3) Recommend the Negotiated Procurement for the Supply and Delivery of Five-Room Prefabricated Barracks upon endorsement by the end-user to the BAC-G after aforecited mandatory review.
