**RESOLUTION NO. 026
(Declaration of Failure of Bidding)**

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act (GAA) Funds under the Department of Transportation, has put on bid the **Contract for the Metro Manila Greenways Project: Makati-Bonifacio Global City Segment Phase 1 – Design and Build of an Elevated Walkway from Metro Manila Metro Rail Transit Buendia Station to Bonifacio Global City**, with an Approved Budget for the Contract (ABC) in the sum of **Pesos: Four Hundred Five Million Six Hundred Ninety Three Thousand and Nine Hundred and 0/100 (PhP405,693,900.00)**, inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Infrastructure, through its Secretariat, advertised the Invitation to Bid on 14 September 2018 in newspaper of nationwide circulation, and on September 14 - 21, 2018 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the said advertisements, two (2) interested bidders bought the bid documents, namely:

1. BF Corporation; and
2. FFJJ Construction and RT Crisman Builders and Construction Supply Joint Venture

WHEREAS, BF Corporation submitted a letter of withdrawal from participating in the bidding of the Project stating the reason of its non-participation, i.e. its cost estimate is above the ABC;

WHEREAS, no bids for the Project were received until the deadline of submission and receipt of bids on 6 November 2018 at 12:00 noon;

WHEREAS, the BAC for Infrastructure declared failure of bidding in accordance with Section 35.1 of the Revised IRR of Republic Act No. 9184, to wit:

"The BAC shall declare the bidding a failure when:

a) No bids are received;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee (BAC) for Infrastructure, hereby RESOLVE as it is hereby RESOLVED:

1. To declare a **FAILURE OF BIDDING** for the Bidding for the Contract of the Metro Manila Greenways Project: Makati-Bonifacio Global City Segment Phase 1 – Design and Build of an Elevated Walkway from Metro Manila Metro Rail Transit Buendia Station to Bonifacio Global City;
2. To conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2 of the Revised IRR of RA 9184, including interview with the bidders who expressed interest; and
3. To proceed with the re-bidding of the Contract for the Metro Manila Greenways Project: Makati-Bonifacio Global City Segment Phase 1 – Design and Build of an Elevated Walkway from Metro Manila Metro Rail Transit Buendia Station to Bonifacio Global City, if the results of the aforementioned mandatory review warrant a re-bidding of the Project pursuant to Section 35.3 of the Revised IRR of RA 9184.
