

WHEREAS, in view of the non-compliance of CIM Technologies, Inc., as the sole bidder, for Lot 3 - Software, BAC-G declared a failure of bidding for the above-mentioned lot for the Procurement of IT Equipment and Software for CY 2023, pursuant to Section 35.1 of the 2016 revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, to wit:

"35.1 The BAC shall declare the bidding a failure when:

 All bids <u>fail to comply with all the bid requirements</u> or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; xxx"

WHEREAS, only the financial envelope of the bidders who "passed" the preliminary examination of the eligibility and technical documents were opened and subjected to a preliminary evaluation by determining the presence or absence of the required financial documents using a "pass/fail" criterion.

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of Columbia Technologies Inc., and





SIM Computer Systems Inc., on 09-18 July 2023 to determine if Columbia Technologies Inc., and SIM Computer Systems Inc., are legally, technically, and financially capable to undertake this project and responsive to all bidding requirements including the specification/terms of reference as stated in the bidding documents;

WHEREAS, in the 18 July 2023 (Tuesday) meeting of the BACG, the BAC-G concurred with the TWG's recommendation, confirming that Columbia Technologies Inc. and SIM Computer Systems Inc. are both eligible, technically, and financially capable to undertake the project.

The Post-Qualification Report is hereby attached as "Annex D".

ACCORDINGLY, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend the following:

- 1. To declare the hereunder bidders:
 - a. Columbia Technologies Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Lot 1-Hardware of Procurement of IT Equipment and Software for CY 2023;
 - SIM Computer Sales Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Lot 2-Internet Access Gateway of Procurement of IT Equipment and Software for CY 2023;
- 2. To award the contract to the following bidders:
 - a. Columbia Technologies Inc., for Lot 1-Hardware for the contract amount of Six Million Six Hundred Seventy-Five Thousand Three Hundred Forty-Five Pesos and 00/100 Only (Php6,675,345.00), inclusive of VAT and all applicable government taxes and fees; and
 - SIM Computer Sales Inc., for Lot 2-Internet Access Gateway of this Contract with the amount of Three Million Seven Hundred Ninety-Five Thousand Pesos and 00/100 Only (Php3,795,000.00), inclusive of VAT and all applicable government taxes and fees; and
- 3. To declare a Failure of Bidding for Lot 3 Software for the Procurement of IT Equipment and Software for CY 2023, in accordance with Section 35.1 of the 2016 RIRR of R.A. No. 9184; and to direct the end-user, the Information and Communications Technology Department (ICTD), to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of R.A. No. 9184.
- 4. To direct the Information and Communications Technology Department (ICTD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.


