DESIGN, CONSTRUCTION, INSTALLATION, AND COMMISSIONING OF THE CONCEPCION-NCC SUB-TRANSMISSION LINE FOR THE NEW CLARK CITY

RESOLUTION NO. 001 (Declaration of Failure of Bidding)

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2019 Corporate Budget, has put on bid the Contract for Design, Supply, Construction, Installation, and Commissioning of the Concepcion-NCC Sub-Transmission Line, to connect the New Clark City (NCC) to the National Grid Corporation of the Philippines (NGCP) Concepcion substation, with an Approved Budget for the Contract (ABC) in the amount of One Hundred Fifty Million Pesos (PhP150,000,000.00), inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Infrastructure, through its Secretariat, advertised the Invitation to Bid on 10 January 2019 in newspaper of nationwide circulation, and on January 10 to 17, 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS) website;
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the said advertisements, six (6) interested bidders bought the bid documents, namely:

- 1. Superserve Corporation;
- 2. AER Construction Development Co., Inc.;
- 3. MN Electro Industrial Supply & Services, Inc.;
- 4. S.L. Development Construction Corporation;
- 5. Wyn Power Corporation; and
- 6. Philcantech Enterprises

WHEREAS, Out of six (6) interested bidders who bought the bidding documents, five (5) submitted their proposals prior to the set deadline for submission and receipt of bids, namely:

- 1. AER Construction Development Co., Inc.;
- 2. MN Electro Industrial Supply & Services, Inc.;
- 3. S.L. Development Construction Corporation;
- 4. Wyn Power Corporation; and
- 5. Philcantech Enterprises

WHEREAS, on February 6, 2019, the envelopes which contained the Eligibility and Technical Requirements of the aforementioned five (5) proponents were opened and subjected to a preliminary evaluation by determining the presence or absence of the required documents using "PASS/FAIL" criterion;

WHEREAS, during the said preliminary evaluation, the BAC declared that the Net Financial Contracting Capacity (NFCC) of Philcantech Enterprises will be verified further during the detailed bid evaluation. The BAC likewise declared that the Eligibility and Technical Requirements of four (4) other bidders are complete but will still be subjected to a more detailed evaluation and verification during the detailed bid evaluation;

WHEREAS, on February 6-7, 2019, the BAC Technical Working Group (TWG) conducted a detailed bid evaluation of the submitted Eligibility and Technical Proposals of the aforementioned five (5) proponents using "PASS/FAIL" criterion. After the presence or absence of the Eligibility and Technical Requirements were ascertained, the Eligibility/Technical Bids of the said five (5) proponents were found to be non-compliant with the eligibility/technical requirements stipulated in the Bidding Documents for the project, and consequently rated "FAILED", to wit:
