WHEREAS, The said proponents submitted their accomplished eligibility documents before the deadline of submission on 16 August 2019, 9:30AM

WHEREAS, On the same day, at 10:00 AM, the accomplished eligibility documents of the two (2) proponents were opened and checked based on the non-discretionary "pass/fail" criterion. The two (2) proponents passed the Eligibility Check and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:
