DECLARATION OF HIGHEST RATED AND RESPONSIVE BID (HRRB)

Consulting Services for the Advance Preliminary Works of Subic-Clark Railway Project

WHEREAS, on September 13, 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract (ABC) is Pesos: Sixty-Eight Million Six Hundred Seventy Nine Thousand Four Hundred Forty Two and 00/100 Pesos (PhP68,679,442.00), inclusive of all applicable taxes, fees and other charges, to be completed within ten (10) months;

WHEREAS, pursuant to BAC-C Resolution No. BC-2018-039 dated 15 October 2018, Foresight Development and Surveying Company (FDSC) was declared as the bidder with the Highest Rated Bid (HRB) for the consulting services;

WHEREAS, the evaluation procedure adopted for the procurement was the Quality Cost Based Evaluation (QCBE) System, wherein the technical and financial proposals were given numerical weights equivalent to 85% and 15%, respectively. Only the financial proposals of bidders who met the minimum technical score of 70% were opened;

WHEREAS, FDSC's financial bid is in the amount of Pesos: Sixty Four Million Ten Thousand Two Hundred Forty and 00/100 (Php64,010,240.00), inclusive of all applicable taxes and fees;

WHEREAS, on December 18, 2018, negotiation with the FDSC was conducted pursuant to Section 33.2.5 of the revised IRR of RA 9184;

WHEREAS, after the conduct of successful negotiation, the Technical Working Group (TWG) was instructed to conduct the post-qualification activities to verify, validate, and ascertain all statements made and documents submitted by FDSC;

WHEREAS, on December 19, 2018, the TWG undertook the following post qualification activities:

- 1. Conducted an ocular visit at FDSC's office building at Unit 708 B to 711 B, Regalia Park Condominium, No. 150 P.Tuazon Avenue, Cubao, Quezon City;
- 2. Validated the original copies of Class A legal documents, documents in compliance with labor laws such as latest payment to SSS, PhilHealth, and Pag-ibig Fund, and supporting documents for completed and on-going projects;

3. Conducted face to face and telephone interviews with the nominated key personnel to ensure availability and commitment to render the required services under the Terms of Reference;

4. Verified positive feedback on the performance of services from their previous clients through phone calls.

NOW THEREFORE, after deliberation and premises considered, we, the members of the BAC-C hereby RESOLVE to recommend the approval of the following:

1. DECLARE Foresight Development and Surveying Company as the bidder with the **Highest Rated and Responsive Bid (HRRB)** for the Consulting Services for the Advance Preliminary Works of Subic-Clark Railway Project;

2. AWARD the contract to Foresight Development and Surveying Company in the amount of Pesos: Sixty Four Million Ten Thousand Two Hundred Forty and 00/100 (Php64,010,240.00), inclusive of all applicable taxes, fees and other charges, to be completed within 10 months;

3. DIRECT the end user to request for the issuance of the Certificate of Funds Availability (CFA) for the procurement prior to the award of the contract;

4. DIRECT the end user to submit to the BAC-C an evaluation of the performance of the consultant at the end of the contract; and

5. DIRECT the end user to furnish the BAC-C copies of the duly conformed Notice of Award, Notice to Proceed, as well as the executed contract, and all supporting documents pursuant to the procurement.
