## BIDDING FOR THE SUPPLY AND DELIVERY OF TWENTY SEVEN (27) BRAND NEW UNITS OF MOTOR VEHICLE

## RESOLUTION OF AWARD (RESO NO. BG2019-003)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Bidding for the Supply and Delivery of Twenty Seven (27) Brand New Units of Motor Vehicle with an Approved Budget for the Contract (ABC) in the amount of Forty-Six Million Seven Hundred Four Thousand & 00/100 (PhP46,704,000.00) inclusive of VAT and all other applicable government taxes, fees and other charges.

**WHEREAS**, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 14 December 2018 (Friday) in the following:

- a) DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b) BCDA Website;
- c) Newspaper of general circulation; and,
- d) In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, two (2) prospective bidders, Toyota Pasong Tamo Inc. (TPTI) and Toyota Quezon Avenue Inc. bought the bid documents.

WHEREAS, on 07 January 2019 (Monday), on the scheduled Opening of Bids, the BAC for Goods received 2 proposals from above-named bidders. During this event, the bidders, having submitted the required eligibility documents, were found eligible and thus, their financial proposals were opened.


WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, TPTI passed and was declared the Lowest Calculated Bid for the following respective Lots:

- a) Lot A: in the amount of *Nine Million Two Hundred One Thousand Pesos & 00/100 (PhP9,201,000.00)*, inclusive of all applicable taxes and fees.
- b) Lot B: in the amount of Seven Million Seven Hundred Forty-Eight Thousand Pesos & 00/100 (PhP7,748,000.00), inclusive of all applicable taxes and fees.
- c) Lot C: in the amount of *Ten Million Four Hundred Forty Thousand and Five Hundred Pesos & 00/100 (PhP10,440,500.00)*, inclusive of all applicable taxes and fees.
- d) Lot D: in the amount of *Fifteen Million Six Hundred Forty-Five Thousand Pesos & 00/100* (*PhP15,645,000.00*), inclusive of all applicable taxes and fees.



WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 09 January 2019 (Wednesday) to determine whether TPTI is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by TPTI, its bid has been found Complying and Responsive. The Post-Qualification Report is hereby attached as Annex "B".

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- 1. To declare **Toyota Pasong Tamo Inc.** as the bidder with the Lowest Calculated and Responsive Bid in the Bidding for the Supply and Delivery of Twenty Seven (27) Brand New Units of Motor Vehicle:
- 2. To award the Contract to **Toyota Pasong Tamo Inc.** in the total bid amount of *Forty-Three Million Thirty-Four Thousand Five Hundred Pesos & 00/100 (PhP43,034,500.00*), inclusive of all applicable taxes and fees, with the following breakdown for each of the respective Lots:
  - a. Lot A: in the amount of *Nine Million Two Hundred One Thousand Pesos & 00/100 (PhP9,201,000.00)*, inclusive of all applicable taxes and fees.
  - b. Lot B: in the amount of Seven Million Seven Hundred Forty-Eight Thousand Pesos & 00/100 (PhP7,748,000.00), inclusive of all applicable taxes and fees.
  - c. Lot C: in the amount of *Ten Million Four Hundred Forty Thousand and Five Hundred Pesos & 00/100 (PhP10,440,500.00)*, inclusive of all applicable taxes and fees.
  - d. Lot D: in the amount of Fifteen Million Six Hundred Forty-Five Thousand Pesos & 00/100 (PhP15,645,000.00), inclusive of all applicable taxes and fees.
- 3. To issue the Notice of Award to Toyota Pasong Tamo Inc. (copy attached); and,
- 4. To direct the Premises Administration & Transportation Services Division, being the end-user, to furnish the BAC for Goods of copies of the duly conformed to Notice of Award, Notices to Proceed and the duly executed contract agreement.
