PROCUREMENT FOR THE SUPPLY AND DELIVERY OF FOUR (4) UNITS OF MOTOR VEHICLES

RESOLUTION NO.BG-2023-C24

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2023 Corporate Operating Budget (COB), applied the sum of **Seven Million Seven Hundred Eighty Thousand Pesos & 00/100 Only (Php7,780,000.00)**, inclusive of VAT and all applicable government taxes and fees, as the Approved Budget for the Contract (ABC) for the **Procurement for the Supply and Delivery of Four (4) Units of Motor Vehicles**, broken down as follows:

WHEREAS, on 01 June 2023, BAC-G, through its Secretariat, advertised/posted the Invitation to Bid, including the bidding documents, on the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted the Pre-bid Conference on 14 June 2023 at 9:30 AM which was attended by the following prospective bidders;

- a. Subic GS Auto Inc./Hino Paranaque Metro Manila
- b. SM Agri-Mac Trading

WHEREAS, the prospective bidders have the option to submit a bid offer on any or all lots and evaluation and contract award will be undertaken on a per-lot basis;

WHEREAS, in response to said advertisements, two (2) bidders submitted their bids before the deadline of submission of bids at 09:00 AM on 04 July 2023 (Tuesday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City, viz:

WHEREAS, during the Opening of Bids on 04 July 2023 (Tuesday) at 10:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G received and opened the bid from the above-mentioned bidders and noted the following:

WHEREAS, considering that no bid was received for **Lot C: Two (2) units Motorcycle**, BAC-G declared a failure of bidding for the said lot pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

WHEREAS, only the financial envelopes of the bidders who “passed” the preliminary examination of the eligibility and technical documents were opened and subjected to a preliminary evaluation by determining the presence or absence of the required financial documents using a “pass/fail” criterion;

WHEREAS, the Technical Working Group (TWG) conducted a detailed evaluation of the submitted Financial Proposals of the two (2) eligible bidders, and recommended the following;

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X (Post-Qualification) of the 2016 RIRR of RA 9184, the BAC-G-Technical Working Group (TWG) conducted a Post-Qualification Evaluation on **Subic GS Auto Inc./Hino Paranaque Metro Manila**, and **SM**

Agri-Mac Trading, on 13 to 25 July 2023 to determine if **Subic GS Auto Inc./Hino Paranaque Metro Manila**, and **SM Agri-Mac Trading**, are legally, technically, and financially capable to undertake the project and responsive to all the bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

WHEREAS, in the 31 July 2023 (Monday) meeting of the BAC-G, its members concurred with the TWG's recommendation, confirming that **Subic GS Auto Inc./Hino Paranaque Metro Manila** and **SM Agri-Mac Trading** are both eligible, technically, and financially capable to undertake the project.

The Post-Qualification Report is hereby attached as "Annex D".

ACCORDINGLY, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend the following:

1. To declare the following bidders:
 - a. **Subic GS Auto Inc./Hino Paranaque Metro Manila** as the Single Calculated and Responsive Bidder (SCRB) for **Lot A: One (1) Automotive Fire Apparatus**; and
 - b. **SM Agri-Mac Trading**, as the Single Calculated and Responsive Bidder (SCRB) for **Lot B: One (1) Farm Tractor**.
2. To award the contract to the following bidders:
 - a. **Subic GS Auto Inc./Hino Paranaque Metro Manila**, for **Lot A: One (1) Automotive Fire Apparatus** in the total amount of **Five Million Nine Hundred Eighty Five Thousand Pesos and 00/100 Only (Php5,985,000.00)**, inclusive of VAT and all applicable government taxes and fees; and
 - b. **SM Agri-Mac Trading**, for **Lot B: One (1) Farm Tractor** in the total amount of **One Million Four Hundred Eighty Five Thousand Pesos and 00/100 Only (Php1,485,000.00)**, inclusive of VAT and all applicable government taxes and fees; and
3. To direct the **Procurement and Property Management Department (PPMD) - General Services Division (GSD)**, being the end-user unit, to submit to BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
