## **DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS**

## CONSTRUCTION AND MANAGEMENT SUPERVISION FOR THE AIRPORT (CIA) TO NEW CLARK CITY (NCC) ACCESS ROAD

WHEREAS, the procurement for the above subject was approved by the BCDA Board with an Approved Budget for the Contract (ABC) amounting to Pesos: One Hundred Seventeen Million 00/100 Pesos (PhP 117,000,000.00), inclusive of all applicable taxes and fees, to be completed within twenty one (21) months;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure, wherein the technical and financial proposals shall be given a corresponding weight of 85% and 15%, respectively. The consultant must pass the required 70% minimum score;

WHEREAS, on May 21, 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

**WHEREAS,** in response to the said advertisement, the following firms responded and secured Eligibility Documents for the above services:

- a. Joint Venture between DCCD Engineering Corporation and Katahira & Engineers International
- b. Joint Venture between Foresight Development & Surveying Company and Ernesto S. De Castro Associates (ESCA), Inc.
- c. Joint Venture between Filipinas Dravo Corporation and PERTCONSULT International
- d. Design Science, Inc.

WHEREAS, the above proponents submitted their accomplished eligibility documents before the deadline of submission on June 6, 2018, 10:30am;

WHEREAS, on the same day, at 11:00am, the accomplished eligibility documents of the four (4) proponents were opened based on the non-discretionary "pass/fail" criterion. The four (4) proponents passed the Eligibility Check and were evaluated for shortlisting;

WHEREAS, during the detailed evaluation of the eligibility proposal, Foresight Development & Surveying Company and ESCA Inc. joint venture did not submit a completed CMS project with a contract amount equivalent to 50% of the ABC as required under the TOR;

- 2. Issue Notice of Eligibility to the said proponents inviting them to bid for the Construction and Management Supervision of the CIA to NCC Access Road; and
- 3. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings.
