DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

CONSULTING SERVICES FOR THE SPECIALIZED COMMUNICATION PROGRAM: STRATEGIC REGIONAL COMMUNICATION AND INVESTOR RELATIONS CAMPAIGN FOR CLARK

WHEREAS, the BCDA Board approved the procurement for the above subject with an Approved Budget for the Contract (ABC) amounting to **Pesos: Eight Million Five Hundred Thousand and 00/100 (PhP 8,500,000.00)**, inclusive of all applicable taxes, fees and other charges which shall be completed within six (6) months;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality-Based Evaluation (QBE) procedure, wherein the Consultant must garner at least the required 70% minimum score in order to be shortlisted;

WHEREAS, on 16 June 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PHILGEPS and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, the following firms responded and secured Eligibility Documents for the above services:

- 1. EON (EVENTS ORGANIZER NETWORK), INC.; and
- 2. GREEN BULB PUBLIC RELATIONS, INC.

WHEREAS, the above proponents submitted their accomplished eligibility documents before the deadline for the submission on 03 July 2018, 11:00AM;

WHEREAS, on the same day, at 11:30AM, the accomplished eligibility documents of the two (2) proponents were opened based on the non-discretionary "pass/fail" criterion;

WHEREAS, the two (2) proponents passed the Eligibility Check and were thus evaluated for shortlisting;

WHEREAS, the results of the evaluation based on the submitted technical documents are as follows:

WHEREAS, based on the above results, the two (2) proponents garnered a total score above the required minimum score of 70% for shortlisting;
