DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

**CONSULTING SERVICES FOR THE ADVANCE PRELIMINARY WORKS OF SUBIC-CLARK
RAILWAY PROJECT**

WHEREAS, on August 29, 2018, the BCDA Board approved the procurement for the above services with an Approved Budget for the Contract (ABC) amounting to **Sixty Eight Million Six Hundred Seventy Nine Thousand Four Hundred Forty Two and 00/100 (Php 68,679,442.00)**, inclusive of all applicable taxes and fees, to be completed within 10 months;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure, wherein the technical and financial proposals shall be given a corresponding weight of 85% and 15%, respectively. The proponents must pass the required 70% minimum score;

WHEREAS, on September 13, 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, the following firms responded and secured Eligibility Documents for the above services:

- a. Foresight Development and Surveying Company
- b. J.F. Cancio & Associates

WHEREAS, the above proponents submitted their accomplished eligibility documents before the deadline of submission on October 2, 2018, 9:00am;

WHEREAS, on the same day, at 10:00am, the accomplished eligibility documents of the two (2) proponents were opened based on the non-discretionary "pass/fail" criterion;

WHEREAS, the two (2) proponents passed the Eligibility Check thus and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:


