5.	Whether the Resettlement Action Plan is the responsibility of BCDA or the winning bidder?	The relocation/resettlement of the affected properties is the responsibility of BCDA.
6.	Whether the design of Sewer Treatment Plant (STP) for the proposed Bonifacio South Properties is included in the scope of works of the winning bidder?	No, the design of STP is not included in the scope of works of the winning bidder but the winning bidder is required to study the tapping points.
7.	Whether another site inspection can be scheduled for the NAMRIA Segment?	The schedule for site inspection for all segments, as coordinated with all the interested bidders, shall only be once.
