RESOLUTION NO. 06 (Declaration of LCRB)

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the CONSTRUCTION OF AIRPORT TO NCC ACCESS ROAD PHASE 2 (Aranguren-Dapdap Segment), located at New Clark City, Capas, Tarlac with an Approved Budget for the Contract (ABC) in the amount of Three Billion Two Hundred Twenty-Eight Million Six Hundred Five Thousand Five Hundred Sixty-Four Pesos and 43/100 (Php3,228,605,564.43), inclusive of all applicable taxes and fees, under a modified payment scheme.

WHEREAS, the SBAC for NCC Access Roads, through its Secretariat, advertised the Invitation to Bid on 14 January 2019 in a newspaper of nationwide circulation, and on January 14 to 20, 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the said advertisements, twenty-three (23) interested bidders bought the bid documents, namely:



WHEREAS, there were only thirteen (13) proponents who submitted their bid proposals for the project prior to the deadline set for the submission of bids. During the Opening of Bids on 11 April 2019, the first envelopes (which contained the eligibility/technical requirements) of the 13 proponents were opened and subjected to a preliminary evaluation which is checking the presence or absence of the required documents using "pass/fail" criterion;

WHEREAS, after the presence or absence of the required documents were ascertained, the first envelope of JH Pajara Construction Corporation/The 13th Bureau of China City Construction Philippines / 13th CCCC China (Consortium), which contained their eligibility/technical requirements, was rated "FAILED" due to the absence of Tax Clearance or the appropriate equivalent documents or any document as substitute for valid Tax Clearance of 13th CCCC China;

WHEREAS, the second envelopes, which contained the financial proposals, of the twelve (12) proponents who "passed" the preliminary examination of the eligibility/technical requirements were opened. The financial bids of these proponents were rated "PASSED" during the preliminary evaluation of the financial bids and were considered for the detailed evaluation of the eligibility/technical bids and for the comparison of financial bids. Table below shows the bid amount of the 12 proponents (as read):



WHEREAS, the detailed evaluation and verification of the bids of the 12 proponents, whose Eligibility/Technical Requirements and Financial Proposals were rated "PASSED", were conducted on April 15 to May 10, 2019, pursuant to Sec. 30 of the Revised Implementing Rules and Regulations (IRR) of RA 9184, to determine the bidder with the Lowest Calculated Bid (LCB) who shall undergo the post-qualification process. WHEREAS, consequent to the above results of the said detailed evaluation and verification of bids, the BAC Resolution No. 03 was issued on 14 May 2019, declaring C.M. Pancho Construction, Inc. (CMPCI) as the bidder with the Lowest Calculated Bid (LCB) for the construction of Airport to NCC Access Road Phase 2 (Aranguren-Dapdap Segment) at New Clark City;

WHEREAS, on May 21 to June 4, pursuant to Section 34 of the Revised IRR of R.A. 9184, the SBAC Technical Working Group (TWG) conducted Post-Qualification on the bidder with LCB to determine whether it is compliant and responsive to the requirements and conditions specified in the Bidding Documents;

WHEREAS, after careful examination, validation and verification of all the eligibility, legal, technical and financial documents submitted to the SBAC, the TWG, in its Post-Qualification Report (attached as Annex A), recommended the award of the contract to CMPCI who was found compliant and responsive;

WHEREAS, CMPCI is not included in the GPPB List of Blacklisted Constructors as of June 30, 2019;

WHEREAS, a certain director of JEL Construction Corporation (JELCON), Mr. Teddy Bustamante sent a letter dated 27 June 2019 to BCDA addressed to its President and CEO, Vivencio B. Dizon, informing BCDA that C.M. Pancho made misrepresentation/false statement in its bid submission because it was never a sub-contractor of Cavite-Laguna Expressway (CALAX) Project as far as the records of the Department of Public Works and Highways (DPWH) are concerned;

WHEREAS, on the basis of Mr. Bustamante's letter, the SBAC conducted further verification and consultations on the allegations stated in said letter;

WHEREAS, as part of SBAC's due diligence and consultations, it sought the advice/legal opinion of BCDA's Legal Services Department on the allegations of Mr. Bustamante and other related issues as far as the allegations of Mr. Bustamante on the bid of C.M. Pancho is concerned;

WHEREAS, on 23 July 2019, the SBAC received the opinion of BCDA's Legal Services Department (attached as Annex B) stating, among others, that "there is no startling inconsistencies between the statement declared by CMPCI vis-à-vis the letters, agreement and contract presented in support of said statement. In other words, the established fact based on the submission of documents for eligibility in the bidding process belies the unfounded allegations, accusations and charges of JELCON against CMPCI. Xxx, there is no misrepresentation on the part of CMPCI as alleged by JELCON. The alleged invalidity of the Subcontract Agreement between DMCI and CMPCI is a matter which should be raised by a party to the contract or the entity or person who is affected thereby."
