- ANTECEDENTS -

BCDA is in need of twenty-one (21) units of color multifunction copy machines for the day-to-day demand of its printing and photocopying machines. However, the purchase of these machines may not be advantageous to the government because of its high cost of maintenance and repair.

The most advisable and cost-efficient way of satisfying this demand for printing and photocopying services is through the rental of these multifunction copy machines.

BCDA invites Bids for certain goods and ancillary services, viz., for the rental of twenty-one (21) units of color multifunction copy machines for the day-to-day demand of its printing and photocopying services and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Nine Hundred Eighty-Four Thousand Pesos and 00/100 Centavos (Php2,984,000.00)** inclusive of VAT and all applicable taxes and fees (herein called "the Contract Price").
