RESOLUTION OF AWARD (RESO NO. BG2018-031)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Procurement of Security Services for AOR-III - Bataan Technology Park, Morong, Bataan with an Approved Budget for the Contract (ABC) of Seven Million Nine Hundred Fifty-Seven Thousand and One Hundred Eighty Pesos & 00/100 (PhP7,957,180.00), inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 09 October 2018 in the following:

- a) DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b) BCDA Website; and,
- c) In a conspicuous place reserved for the purpose in the premises of BCDA

WHEREAS, in response to said advertisements, Two (2) prospective bidders bought the bid documents, namely: Urduja Security Services, Inc. and Defense Strategist Security Services, Inc.

WHEREAS, on 29 October 2018, on the scheduled Opening of Bids, the BAC for Goods received 2 proposals from above-named bidders. During this event, the bidders, having submitted the required eligibility documents, were found eligible and thus, their financial proposals were opened.

WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, Urduja Security Services Inc. passed and was declared the Lowest Calculated Bid in the amount of Seven Million Seven Hundred Twenty Two Thousand One Hundred Eighty Pesos & 00/100 (PhP7,722,180.00), inclusive of all applicable taxes and fees. The Abstract of Bids is hereby attached as "Annex "A".

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 06 November 2018 to determine whether Urduja Security Services, Inc. is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.
