DECLARATION OF BIDDER WITH THE SINGLE RATED BID

Consulting Services for the Inauguration of New Clark City Phase 1A

WHEREAS, The BCDA Board approved the procurement of the above consulting service with an Approved Budget for the Contract (ABC) in the amount of Pesos: Pesos: Fifteen Million and 00/100 (PhP15,000,000.00), inclusive of all applicable taxes and fees, to commence upon receipt of the Notice to Proceed (NTP) and shall remain in full force and effect until 31 January 2020;

WHEREAS, On 31 July 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in a newspaper of general nationwide circulation, in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, Pursuant to BAC-C Resolution No. BC2019-027 dated 06 September 2019, Video Sonic Corporate Communications, Inc. and EON (Events Organizer Network), Inc. were declared ELIGIBLE and SHORTLISTED, and were allowed to proceed to the next stage of the bidding process;

WHEREAS, The evaluation procedure adopted is the Quality-Based EValuation (QBE) procedure wherein prospective proponents are required a minimum technical score of 70%;

WHEREAS, The abovementioned consulting firms submitted their Technical and Financial Proposals before the deadline on 30 September 2019, 9:00 AM;

WHEREAS, On the same date, at 09:30AM, the Technical Working Group (TWG) conducted the Opening of Bids for the preliminary technical evaluation;

WHEREAS, During the conduct of the opening and preliminary evaluation of the technical proposals, the following were observed:

- Video Sonic Corporate Communications, Inc. passed all the required documents under the Checklist of Requirements of the Bidding Documents; and
- 2. EON, Inc. failed to attach in the submission of their TPF 4: Description of the Methodology and Work Plan for Performing the Project (TPF 4) an electronic file containing their concept proposal to be used in the oral presentation. The TWG opened both original and copy of the sealed technical proposals but at the time of the opening, no usb/flash drive was found. Further, the representative of EON, when asked about it, could not attest whether or not they submitted an electronic file;

WHEREAS, The BAC-C declared EON, Inc. as non-compliant as to the submission of technical requirements and allow only Video Sonic Corporate Communications,Inc. to proceed with the oral presentation stage of the bidding process;

WHEREAS, At 1:00 PM of the same day, Video Sonic Corporate Communications, Inc. made an oral presentation to the BAC-C members and select evaluators from Management, namely: Ms. Kathy Bacosa (representative of PCEO Vince Dizon), Ms. Leilani Barlongay-Macasaet (Head, Public Affairs Department) and Ms. Michelle SJ De Vera (end-user, Investment Promotion and Marketing Department). The BACC and evaluators rendered the evaluation of the Plan of Approach and Methodology submitted by the bidder.

WHEREAS, Based on the approved detailed evaluation criteria, the TWG proceeded with the detailed evaluation of Video Sonic Corporate Communications, Inc.'s technical proposal and the results are as follows:
