WHEREAS, the Bases Conversion and Development Authority (hereinafter referred to as BCDA) through its Corporate Operating Budget for 2019 has put on bid the Supply, Delivery and Installation of Five-Room Prefabricated Barracks with an Approved Budget for the Contract (ABC) in the amount of One Million Five Hundred Thousand Pesos (Php1,500,000.00), inclusive of delivery charge, installation cost, and all applicable taxes, duties, and fees, broken down into two (2) lots:

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 06 March 2019 in the following:

2) DBM Philippine Government Electronic Procurement System (PhilGEPS) website; and,

3) in a conspicuous place reserved for the purpose in the premises of BCDA continuously for seven (7) calendar days.

WHEREAS, given said advertisements, no prospective bidder purchased the bidding documents and no bid was received by the BCDA on 10 April 2019 at 10:00AM, the deadline for the submission of bids.

WHEREAS, the BAC-G declared failure of bidding pursuant to Section 35.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, to wit:
