**RESOLUTION OF AWARD
(RESO NO. BG2018-034)**

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the **Bidding for the Supply and Delivery of Construction Tools and Materials for the Rehabilitation of Primary Electrical Lines at the Bataan Technology Park in Morong, Bataan** with an Approved Budget for the Contract (ABC) of **Five Million Nine Hundred Twenty-One Thousand Pesos and 00/100 (PhP5,921,000.00)**, inclusive of VAT, all transport/hauling cost and all applicable taxes and fees;

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 05 December 2018 (Wednesday) in the following:

- a) DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b) BCDA Website; and,
- c) In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, two prospective bidders, **C.B. Garay Philwide Builders** and FBF Industrial Sales and Services bought the bid documents.

WHEREAS, on 27 December 2018 (Thursday), on the scheduled Opening of Bids, the BAC for Goods received two proposals from above-named bidders. During this event, the bidders, having submitted the required eligibility documents, were found eligible and thus, their financial proposals were opened.

WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, **C.B. Garay Philwide Builders** passed and was declared the Lowest Calculated Bid in the amount of **Five Million Two Hundred Eighty-One Thousand Eight Hundred Seventy-Six Pesos & 40/100 (PhP5,281,876.40)**, inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as "Annex "A".*

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 28 December 2018 (Friday) to determine whether **C.B. Garay Philwide Builders** is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by **C.B. Garay Philwide Builders**, its bid has been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B".*
