BIDDING FOR THE PROCUREMENT OF VIDEO CONFERENCING SYSTEM FOR 2019

RESOLUTION OF AWARD (RESO NO. BG2019-007)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Procurement of Video Conferencing System for 2019 with an Approved Budget for the Contract (ABC) of *Two Million and Seven Hundred Thousand Pesos & 00/100 (Php2,700,000.00)*, inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 05 April 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- BCDA Website; and
- In a conspicuous place reserved for the purpose in the premises of BCDA

WHEREAS, in response to said advertisements, two (2) prospective bidders bought the bid documents, namely, Audio-Video Solutions Corporation (A-V Solutions) for lots A & C and Kollab Guru Group Inc. (KGGI) for lots A & B.

WHEREAS, on 30 April 2019, on the scheduled Opening of Bids, the BAC for Goods received two (2) proposals from both above-mentioned bidders for the following respective lots:

- a. Audio-Video Solutions Corporation (A-V Solutions) submitted proposals for Lots A & C; and
- b. Kollab Guru Group Inc. (KGGI) submitted proposals for Lots A & B.

WHEREAS, during this event, both bidders having submitted the required eligibility documents were found eligible, thus, their financial proposals were opened.

WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, A-V Solutions passed and was declared the Single Calculated Bid for Lot C; KGGI passed and was declared Lowest Calculated Bid for Lot A and Single Calculated Bid for Lot B. The Abstract of Bids is hereby attached as "Annex "A".

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 23 May 2019 to determine whether A-V Solutions and KGGI are compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by A-V Solutions and KGGI their respective bids have been found Complying and Responsive. The Post-Qualification Report is hereby attached as Annex "B".

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare AUDIO-VIDEO SOLUTIONS CORPORATION with Single Calculated and Responsive Bid for Lot C for the Bidding for the Procurement of Video Conferencing System for 2019;

To declare KOLLAB GURU GROUP INC. with Lowest Calculated Bid for Lot A and Single Calculated Bid for Lot B for the Bidding for the Procurement of Video Conferencing System for 2019;

2. To award the Contract to AUDIO-VIDEO SOLUTIONS CORPORATION in the amount of Eight Hundred Forty Eight Thousand & 00/100 (Php848,000.00) for Lot C, inclusive of all applicable taxes and fees;

To award the Contracts to KOLLAB GURU GROUP INC. in the following Lots with respective amounts, inclusive of all applicable taxes and fees:

- a. For Lot A: One Million Two Hundred Forty Seven Thousand Seven Hundred Eighty Pesos & 00/100 (PhP1,247,780.00); and
- b. For Lot B: Four Hundred Fourteen Thousand One Hundred Twenty Pesos & 00/100 (PhP414,120.00).
- 3. To issue the Notice of Award to AUDIO-VIDEO SOLUTIONS CORPORATION and KOLLAB GURU GROUP INC. (copy attached); and,
- 4. To direct the Information and Communications Technology Department, being the end-user, to furnish the BAC for Goods of copies of the duly conformed to Notice of Award, Notices to Proceed and the duly executed contract agreement.
