Engagement of the Services for a Digital / Online Media Placement Agency

DECLARATION OF FAILURE OF BIDDING

WHEREAS, on 01 March 2019, the BAC-C issued BAC-C Resolution BC-2019-004 recommending the Engagement of the Services of a Digital / Online Media Placement Agency in accordance with Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of RA 9184 on Small Value Procurement;

WHEREAS, in the same resolution, the BAC-C delegated the procurement to the Investment Promotion and Marketing Department (IPMD) of BCDA, end user and proponent of the consulting service;

WHEREAS, on 08 March 2019, BCDA advertised the Request for Quotation (RFQ) for the consulting service in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for three (3) calendar days;

WHEREAS, the procurement for the above services has an Approved Budget for the Contract (ABC) amounting to Pesos: One Million and 00/100 (Php1,000,000.00), inclusive of all applicable taxes and fees to be completed within 12 months;

WHEREAS, in a memo dated 15 March 2019, the end user reported to the BAC-C that no bids were received on 12 March 2019 at 10:00 AM, the deadline for submission of quotations;

WHEREAS, the end-user requested the BAC-C for a declaration of failure of bidding and termination of the bidding process;

WHEREAS, Section 35.1.a of the Revised IRR of RA 9184 provides that the BAC shall declare a Failure of Bidding when no bids are received;

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. DECLARE a FAILURE OF BIDDING for the Engagement of the Services of a Digital / Online Media Placement Agency under Section 35.1a of the Revised IRR of RA 9184;
2. DIRECT the end user, in case of rebidding of the consulting service, to conduct a mandatory review of the Terms of Reference (TOR) and submit to BAC-C its report and recommendation;
