DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

Consulting Services for the Construction Management and Supervision (CMS) of the Airport (CIA) to New Clark City (NCC) Access Road Phase 2 (Aranguren-Dapdap Segment)

WHEREAS, The procurement for the above subject was approved by the BCDA Board with an Approved Budget for the Contract (ABC) amounting to Pesos: Ninety One Million Seven Hundred Sixty One Thousand Six Hundred Pesos and 00/100 (PhP 91,761,600.00), inclusive of all applicable taxes and fees, to be completed within twenty-one (21) months;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure, wherein the technical and financial proposals shall be given a corresponding weight of 85% and 15%, respectively. The consultant must pass the required 70% minimum score;

WHEREAS, on 12 April 2019, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in conspicuous premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, the following firms responded and secured Eligibility Documents for the above services:

- Joint Venture between KE Asia, Inc. (KEA) and Foresight Development and Surveying Company (FDSC)
- b. Joint Venture between Design Science, Inc. (DSI) and Philipps Technical Consultants Corporation (PTCC)

WHEREAS, the above proponents submitted their accomplished eligibility documents before the deadline of submission on 09 May 2019, 9:00 AM;

WHEREAS, on the same day, at 9:30 AM, the accomplished eligibility documents of the two (2) proponents were opened based on the non-discretionary "pass/fail" criterion. The two (2) proponents passed the Eligibility Check and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:

WHEREAS, based on the above results, the two (2) proponents garnered a total score above the required minimum score of 70% for shortlisting;
