DECLARATION OF THE BIDDER WITH THE SINGLE RATED BID (SRB)

Consulting Services for the Production of the BCDA 2018 Annual Report

WHEREAS, on February 22, 2019, BCDA advertised the Request for Expression of Interest (REI) for the Consulting Services for the Production of the BCDA 2018 Annual Report in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA, continuously for seven (7) days. The project has an Approved Budget for the Contract (ABC) amounting to Pesos: One Million Five Hundred Thousand Pesos PhP (1,500,000.00), inclusive of all applicable taxes and fees to be completed within six (6) months;

WHEREAS, in response to the REI, the following bidders submitted their accomplished eligibility documents before the deadline of submission on March 13, 2019 at 10:00 AM and were subjected to eligibility check based on the non-discretionary "pass/fail" criterion:

- a. FORA, Strategic Communications Consultancy, Inc.; and
- b. Team Manila Graphic Design Studio, Inc.

WHEREAS, based on the results of the Eligibility Check, the BAC-C issued BAC-C Resolution No. BC-2019-008 declaring FORA Strategic Communications Consultancy, Inc. as Shortlisted and Eligible to proceed to the next stage of the bidding process;

WHEREAS, Team Manila Graphic Design Studio, Inc. was declared ineligible due to its failure to submit its Audited Financial Statements for 2017, as required under the Checklist of Requirements;

WHEREAS, the evaluation procedure to be adopted is Quality-Based Evaluation (QBE) procedure with a required minimum technical score of 70% to be declared as Single Rated Bid (SRB);

WHEREAS, FORA Strategic Communications Consultancy, Inc. submitted its accomplished Technical and Financial Proposals before the deadline of submission on May 09, 2019 at 1:00 PM and passed the preliminary technical evaluation and presented their Plan of Approach and Project Methodology through oral presentation;

WHEREAS, based on the approved detailed evaluation criteria, the technical proposal by FORA Strategic Communications Consultancy, Inc. was found to be compliant to the minimum technical requirements;

WHEREAS, based on further evaluation of the bidder's technical proposal, where the minimum required score is 70%, FORA Strategic Communications Consultancy, Inc. garnered a total score of **80.78%** broken down as follows:
