DECLARATION OF FAILED BIDDING

Consulting Services for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build (BBB) Portal

WHEREAS, The BCDA Board approved the procurement of the above services with an Approved Budget for the Contract (ABC) in the amount of Pesos: Six Million and 00/100 (PhP 6,000,000.00), inclusive of all applicable taxes and fees, to be completed within one (1) year and an additional one (1) month of warranty support;

WHEREAS, The procurement of the said services was undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure wherein the technical and financial proposals was given corresponding weight equivalent to 75% and 25%, respectively;

WHEREAS, On 11 May 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, pursuant to the issuance of BAC-C Resolution No. BC2019-020 dated 02 July 2019, the following bidders were declared ELIGIBLE and SHORTLISTED for the abovementioned services, and were allowed to proceed to the next stage of bidding activities:

- a. Technovore Systems, Inc.; and
- b. Telcom Live Content, Inc.

WHEREAS, on 05 August 2019, only Technovore Systems, Inc. submitted their Technical and Financial Proposal. Telcom Live Content, Inc. did not submit their bidding proposals;

WHEREAS, on the same day, at 10:30 AM, the Technical Proposal of Technovore Systems, Inc. was opened;

WHEREAS, Technovore Systems, Inc. has complied with the submission of the technical documents required under the Bidding Documents. However, during the opening of the technical proposal, it was noted that they failed to submit supporting documents to substantiate the claimed experience under TPF 2 Consultants References and TPF 6 Curriculum Vitae of the Proposed Team;

WHEREAS, the members of the BAC-C Technical Working Group together with a panel of IT evaluators conducted the evaluation of the technical proposal;

WHEREAS, based on the consolidated results of the technical evaluation, Technovore Systems, Inc. garnered a total technical score of 33.53%;

WHEREAS, the above results show that the total technical score garnered by the bidder did not meet the minimum technical score of 70.00%;

WHEREAS, Section 35 of the Revised IRR of RA9184 provides for the authority of the BAC to declare a Failure of Bidding when all bids fail to comply with all the bid requirements, to wit:

35.1 The BAC shall declare the bidding a failure when:

XXX

(c) All bids fail to comply with all the bid requirements xxx (Emphasis supplied)

NOW, THEREFORE, after deliberation and premises considered, we the members of the BAC-C, hereby resolve to recommend the approval of the following:

- 1. DECLARE a FAILURE OF BIDDING for the Consulting Services for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build (BBB) Portal under Section 35.1c of the Revised IRR of RA9184;
- 2. DIRECT the end-user to conduct a mandatory review of the TOR and other bid documents and submit to the BAC-C its report and recommendation on whether to rebid the consulting services, including a revised timeline of procurement;
- 3. DIRECT the BAC-C Secretariat to notify Technovore Systems, Inc. on the results of the technical evaluation and failure of bidding.
