DECLARATION OF BIDDER WITH THE SINGLE RATED AND RESPONSIVE BID

Rebidding for the Consultancy Service for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build (BBB) Portal

WHEREAS, The BCDA Board approved the procurement of the above services with an Approved Budget for the Contract (ABC) in the amount of Pesos: Six Million and 00/100 (PhP 6,000,000.00), inclusive of all applicable taxes and fees, to be completed within one (1) year and an additional one (1) month of warranty support;

WHEREAS, On 27 August 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA Website, PhilGEPS Website, newspaper of general nationwide circulation and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, The evaluation procedure adopted for the procurement was the Quality Cost Based Evaluation (QCBE) System, wherein the technical and financial proposals were given numerical weights equivalent to 75% and 25%, respectively. Only the financial proposals of bidders who met the minimum technical score of 70% were opened;

WHEREAS, Pursuant to BAC-C Resolution No. BC2019-041 dated 15 October 2019, Technovore Systems, Inc. was declared as the bidder with the Single Rated Bid (SRB) having a total rating of 84.44%;

WHEREAS, On 15 October 2019, the BAC-C proceeded with the opening of the financial proposal of Technovore Systems, Inc. The financial bid of said bidder was found to be within the ABC;

WHEREAS, Technovore's financial bid is in the amount of Pesos: Six Million and 00/100 (PhP6,000,000.00), inclusive of all applicable taxes and fees;

WHEREAS, On 16 October 2019, negotiation with Technovore Systems, Inc. was conducted pursuant to Section 33.2.5 of the revised IRR of RA 9184:

WHEREAS, It was agreed during the negotiations that the warranty support shall be increased from one (1) month to two months;

WHEREAS, after the conduct of successful negotiation, the Technical Working Group (TWG) was instructed to conduct the post-qualification activities to verify, validate, and ascertain all statements made and documents submitted by Technovore Systems, Inc.;

WHEREAS, On 21 October 2019, the TWG undertook the following post-qualification activities:

- 1. Conducted an ocular visit of their office address located at 19th Floor Marco Polo Ortigas Manila, Sapphire Road, Ortigas Center, Pasig City;
- 2. Validated the original copies of Class A legal documents, documents in compliance with labor laws such as latest payments to SSS, PhilHealth, and Pag-Ibig Fund, and supporting documents for completed and on-going projects;



- 3. Conducted face-to-face and telephone interviews with all the nominated key personnel to validate work experiences stated in their Curriculum Vitae and to ensure availability and commitment to render the required services under the Terms of Reference; and
- 4. Verified positive feedback on the performance of services from their previous clients through phone calls.

NOW, THEREFORE, After deliberation and premises considered, we, the members of the BAC-C hereby RESOLVE to recommend the approval of the following:

- 1. DECLARE **Technovore Systems, Inc.** as the bidder with the **Single Rated and Responsive Bid** for the Consulting Services for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build (BBB) Portal;
- 2. AWARD the contract to Technovore Systems, Inc. in the amount of **Pesos: Six Million and 00/100 (PhP6,000,000.00)**, inclusive of all applicable taxes, fees and other charges, to be completed within one (1) year and an additional two (2) months of warranty support;
- 3. DIRECT the end user to request for the issuance of the Certificate of Funds Availability (CFA) for the procurement prior to the award of the contract;
- 4. DIRECT the end user to furnish the BAC-C copies of the duly conformed Notice of Award, Notice to Proceed, as well as the executed contract, and all supporting documents pursuant to the procurement; and
- 5. DIRECT the end user to submit to the BAC-C an evaluation of the performance of the consultant at the end of the contract.
