DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

**CONSULTING SERVICES FOR THE DETAILED ARCHITECTURAL AND ENGINEERING DESIGN
FOR THE METRO MANILA GREENWAYS PROJECT: MAKATI-BONIFACIO GLOBAL CITY
SEGMENT PHASE 1-ELEVATED WALKWAY FROM METRO RAIL TRANSIT BUENDIA STATION
TO BONIFACIO GLOBAL CITY**

WHEREAS, on 20 February 2019, the BCDA Board approved the procurement for the Consulting Services for the Detailed Architectural and Engineering Design (DAED) for the Metro Manila Greenways Project: Makati-Bonifacio Global City Segment Phase 1 – Elevated Walkway from Metro Rail Transit (MRT) Buendia Station to BGC with an Approved Budget for the Contract (ABC) amounting to Pesos: Eight Million Two Hundred Thirty-two Thousand and 00/100 (PhP8,232,000.00), inclusive of all applicable taxes and fees, to be completed within one hundred eighty (180) calendar days;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality Based Evaluation (QBE) procedure with 70% minimum score to be shortlisted;

WHEREAS, on 05 March 2019, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, the following firms submitted their accomplished eligibility documents before the deadline of submission on 03 April 2019, 3:00 PM:

- a. Joint Venture between WSP Philippines, Inc. and AMH Philippines, Inc.
- b. Urban Integrated Consultant, Inc. (UICI)

WHEREAS, on the same day, at 3:45 PM, the accomplished eligibility documents of the two (2) proponents were opened based on the non-discretionary “pass/fail” criterion;

WHEREAS, the two (2) proponents passed the Eligibility Check and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:

Proponent	Total Score (Minimum of 70%)
JV between WSP and AMH	80.30%
UICI	90.05%

WHEREAS, based on the above results, both proponents garnered a total score above the required minimum score of 70% for shortlisting;

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. DECLARE the following proponents as SHORTLISTED and ELIGIBLE to proceed to the next stage of bidding activities:
 - a. Joint Venture between WSP Philippines, Inc. and AMH Philippines, Inc.
 - b. Urban Integrated Consultant, Inc. (UICI)
2. ISSUE Notice of Eligibility to the above proponents inviting them to bid for the Consulting Services for the DAED for the Metro Manila Greenways Project: Makati-Bonifacio Global City Segment Phase 1 – Elevated Walkway from MRT Buendia Station to BGC.
