DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

CONSULTING SERVICES FOR THE PREPARATION OF SITE DEVELOPMENT PLAN AND DETAILED ARCHITECTURAL AND ENGINEERING DESIGN FOR THE RELOCATION AND FUNCTIONAL REPLICATION OF THE PHILIPPINE NAVY AND PHILIPPINE MARINE CORPS STRUCTURES/FACILITIES AND UTILITIES

WHEREAS, on November 21, 2018, the BCDA Board approved the procurement for the above services with an Approved Budget for the Contract (ABC) amounting to Pesos: Fifty Eight Million Four Hundred Fifty Two Thousand Eight Hundred and 00/100 (Php58,452,800.00), inclusive of all applicable taxes and fees to be completed within nine (9) months;

WHEREAS, the procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure, wherein the technical and financial proposals shall be given a corresponding weight of 75% and 25%, respectively. The proponents must pass the required 70% minimum score;

WHEREAS, on November 27, 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, the following firms submitted their accomplished eligibility documents before the deadline of submission on January 7, 2019, 8:30 AM:

- a. AIDEA, Inc. & WSP
- b. ESCA, Inc. & GF Partners Architects
- c. Enrique O. Olonan & Associates and Filipinas Dravo Corporation

WHEREAS, on the same day, at 9:00 AM, the accomplished eligibility documents of the three (3) proponents were opened based on the non-discretionary "pass/fail" criterion;

WHEREAS, the three (3) proponents passed the Eligibility Check and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:
