Consulting Services for the Preparation of Detailed Architectural and Engineering Design for the Relocation of Philippine Navy Facilities

DECLARATION OF FAILED BIDDING

WHEREAS, on November 27, 2018, BCDA advertised the Request for Expression of Interest (REI) for the Consulting Services for the Preparation of Detailed Architectural and Engineering Design (DAED) for the Relocation of Philippine Navy Facilities in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, the procurement for the above services has an Approved Budget for the Contract (ABC) amounting to Pesos: Fifty Eight Million Four Hundred Fifty Two Thousand Eight Hundred and 00/100 (Php58,452,800.00), inclusive of all applicable taxes and fees to be completed within nine (9) months;

WHEREAS, on January 23, 2019, the BAC-C issued BAC-C Resolution BC-2019-001 resolving to declare the following as SHORTLISTED and ELIGIBLE bidders:

- a. Joint Venture of Enrique O. Olonan & Associates and Filipinas Dravo Corporation
- b. Joint Venture of AIDEA, Inc. & WSP
- c. Joint Venture of ESCA, Inc. & GF Partners Architects

WHEREAS, on February 7, 2019, at 9:00 AM, the Pre-Bid Conference was held and attended by representatives of all shortlisted and eligible bidders;

WHEREAS, all shortlisted and eligible bidders purchased the bid documents with a cost of Fifty Thousand Pesos (Php 50,000);

WHEREAS, no bids were received on February 19, 2019 at 9:00 AM, the deadline for submission of Technical and Financial Proposals;

WHEREAS, on February 19, 2019 at 9:48 AM, the JV of Aidea Inc. and WSP submitted their Technical and Financial Proposals, after the deadline of submission. The date and time of submission was recorded and the bid documents were returned to the bidder unopened;

WHEREAS, on February 19, 2019 the BAC-C received letters from the Joint Venture (JV) of ESCA Inc. & GF Partners Architects and the JV of Enrique Olonan & Associates and Filipinas Dravo Corporation, two (2) of the shortlisted and eligible bidders, informing the BAC-C that based on their evaluation, their financial proposals will exceed the ABC;

WHEREAS, Section 35.1.a of the Revised IRR of RA 9184 provides that the BAC shall declare a Failure of Bidding when no bids are received;

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. DECLARE a FAILURE OF BIDDING for the Consulting Services for the Preparation of Detailed Architectural and Engineering Design for the Relocation of Philippine Navy Facilities under Section 35.1a of the Revised IRR of RA 9184;
2. DIRECT the end user to conduct a mandatory review of the TOR and other bid documents and submit to BAC-C its report and recommendation on whether to rebid the consulting services, including a revised timeline of procurement;
3. DIRECT the BAC-C Secretariat to write the bidders and request for comments and suggestions on the TOR;
