DECLARATION OF BIDDER WITH THE HIGHEST RATED BID

Consulting Services for the Detailed Architectural and Engineering Design for the Metro Manila Greenways Project: Makati-Bonifacio Segment Phase 1 - Elevated Walkway from Metro Manila Rail Transit Buendia Station to Bonifacio Global City

WHEREAS, on 20 February 2019, the BCDA Board approved the procurement for the abovementioned procurement with an Approved Budget for the Contract (ABC) amounting to Pesos: Eight Million Two Hundred Thirty Two Thousand and 00/100 (PhP 8,232,000.00), inclusive of all applicable taxes and fees, to be completed within one hundred eighty (180) calendar days;

WHEREAS, on 05 March 2019, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS website and in conspicuous premises of BCDA continuously for seven (7) calendar days;

WHEREAS, pursuant to Bids and Awards Committee for Consulting Services (BAC-C) Resolution No. BC2019-013 dated 24 April 2019, Urban Integrated Consultant, Inc. (UICI) and the Joint Venture between WSP Philippines, Inc. and AMH Philippines, Inc. were declared ELIGIBLE and SHORTLISTED, and were allowed to proceed to the next stage of the bidding;

WHEREAS, the evaluation procedure adopted is the Quality-Based Evaluation (QBE) procedure wherein prospective proponents are required a minimum technical score of 70%;

WHEREAS, the proponents submitted their Technical and Financial Proposals before the deadline of submission on 13 June 2019 at 3:00 PM;

WHEREAS, on the same day, at 3:45 PM, the opening and preliminary evaluation of the technical proposals, as well as the oral presentations of the proponents were conducted;

WHEREAS, based on the approved detailed evaluation criteria for the Technical Proposals, the results are as follows:

WHEREAS, based on the above results, the two (2) proponents garnered a total score above the required minimum score for technical proposal of 70%;

WHEREAS, UICI garnered the highest rating with a score of 89.24% and will be invited to the Opening of Financial Proposal and Negotiation;

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. Declare **Urban Integrated Consultants, Inc. (UICI)** as the bidder with the **Highest Rated Bid** for the Consulting Services for the Detailed Architectural and Engineering Design for the

Metro Manila Greenways Project: Makati-Bonifacio Segment Phase 1 - Elevated Walkway from Metro Manila Rail Transit Buendia Station to Bonifacio Global City; and

2. Issue Notice of Highest Rated Bid and Opening of Financial Proposal and Negotiations and Proceed with the opening of the financial proposal and negotiations with said bidder.
