## BIDDING FOR THE PROCUREMENT OF DATA CENTER AND NETWORK SECURITY SOLUTION

## RESOLUTION OF AWARD (RESO NO. BG2018-033)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Bidding for the Procurement of Data Center and Network Security Solution with an Approved Budget for the Contract (ABC) of *Five Million Five Hundred Thousand Pesos* (PhP5,500,000.00) inclusive of VAT and all other applicable government taxes, fees and other charges.

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 05 December 2018 (Wednesday) in the following:

a) DBM Philippine Government Electronic Procurement System (PhilGEPS);

b) BCDA Website; and,

c) In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, only one prospective bidder, CT Link Systems, Inc. bought the bid documents.

WHEREAS, on 27 December 2018 (Thursday), on the scheduled Opening of Bids, the BAC for Goods received one proposal from above-named bidder, CT Link Systems, Inc. During this event, the bidder, having submitted the required eligibility documents, was found eligible and thus, its financial proposal was opened.

WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, CT Link Systems, Inc. passed and was declared the Single Calculated Bid in the amount of Four Million Nine Hundred Seventy-Six Thousand Pesos & 00/100 (PhP4,976,000.00), inclusive of all applicable taxes and fees. The Abstract of Bids is hereby attached as "Annex "A".

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 28 December 2018 (Friday) to determine whether CT Link Systems, Inc. is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by CT Link Systems, Inc., its bid has been found Complying and Responsive. The Post-Qualification Report is hereby attached as Annex "B".

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- 1. To declare CT Link Systems, Inc. as the bidder with the Single Calculated and Responsive Bid for the Procurement of Data Center and Network Security Solution;
- To award the Contract to CT Link Systems, Inc. in the amount of Four Million Nine Hundred Seventy-Six Thousand Pesos & 00/100 (PhP4,976,000.00), inclusive of all applicable taxes and fees;
- To issue the Notice of Award to CT Link Systems, Inc. (copy attached); and,
- To direct the Information & Communications Technology Department, being the end-user, to furnish the BAC for Goods of copies of the duly conformed to Notice of Award, Notices to Proceed and the duly executed contract agreement.
