BIDDING FOR THE ONE (1) YEAR RENTAL OF TWENTY (20) COLOR MULTIFUNCTION COPY MACHINES FOR 2019

RESOLUTION NO. BG-2019-008

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the PROCUREMENT FOR THE ONE (1) YEAR RENTAL OF TWENTY (20) COLOR MULTIFUNCTION COPY MACHINES FOR 2019 with an Approved Budget for the Contract (ABC) of Two Million Nine Hundred Forty Four Thousand Pesos (Php2,944,000.00), inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 15 June 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, two (2) companies, OTUS COPY SYSTEMS, INC. (OTUS) and MCLINK COPY SERVICES, bought the bid documents.

WHEREAS, on 18 July 2019, on the scheduled Opening of Bids, the BAC for Goods received two (2) proposals from MCLINK COPY SERVICES and OTUS. During this event, OTUS submitted their bids late, thus, their envelopes were not opened while MCLINK COPY SERVICES was found to be "ineligible" due to incomplete eligibility requirements. The Abstract of Bids is hereby attached as Annex "A".

WHEREAS, the BAC-G declared failure of bidding pursuant to Section 35.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, to wit:

35.1 The BAC shall declare the bidding a failure when: a. No bids are received; (emphasis supplied) b. All prospective bidders are declared ineligible; c. Xxx.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- 1) Declare **FAILURE OF BIDDING** for the Procurement of One (1) Year Rental of Twenty (20) Color Multifunction Copy Machines for 2019;
- 2) Direct end-user to conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents pursuant to Section 35 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, especially considering that no prospective bidder submitted their bid; and,

3) Recommend re-bidding for the Procurement of One (1) Year Rental of Twenty (20) Color Multifunction Copy Machines for 2019 upon endorsement by the enduser to the BAC-G for re-bidding and completion of the aforecited mandatory review.
