DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

Consultancy Service for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build Build (BBB) Portal

WHEREAS, The BCDA Board approved the procurement of the above services with an Approved Budget for the Contract (ABC) in the amount of Pesos: Six Million and 00/100 (PhP 6,000,000.00), inclusive of all applicable taxes and fees, to be completed within one (1) year and an additional one (1) month of warranty support;

WHEREAS, The procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure wherein the technical and financial proposals shall be given corresponding weight equivalent to 75% and 25%, respectively;

WHEREAS, On 11 May 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, On 07 June 2019, the following firms responded to the said advertisement and secured Eligibility Documents for the abovementioned services before the deadline of 10:30 AM:

- a. Technovore Systems, Inc.,
- b. Telcom Live Content, Inc., and
- c. MyBusyBee, Inc.,

WHEREAS, On the same day, at 11:00 AM, the BAC-C opened the accomplished eligibility documents of the three (3) proponents, however, only two (2) proponents passed the Eligibility Check based on the non-discretionary "pass/fail" criterion;

WHEREAS, The proponent MyBusyBee, Inc. did not pass the eligibility check because it failed to submit an *Audited Financial Statement with stamp "RECEIVED"* by the Bureau of Internal Revenue (BIR)" or its duly accredited and authorized institutions as required under the Checklist of Requirements provided in the Eligibility Documents;

WHEREAS, based on the approved detailed evaluation criteria, all proponents garnered a total score above the required minimum score of 70%;

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

- 1. DECLARE AS SHORTLISTED and ELIGIBLE to proceed to the next stage of bidding activities the following proponents:
 - a. Technovore Systems, Inc.,
 - b. Telcom Live Content, Inc.;
- 2. ISSUE Notice of Eligibility to the said proponents inviting them to bid for the Consulting Services for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build (BBB) Portal;
