RESOLUTION No. BG-2023-013**

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the Corporate Operating Budget and 2023 General Appropriations Act (GAA), intends to apply the sum of **ONE HUNDRED FOURTEEN MILLION FIVE HUNDRED TEN THOUSAND ONE HUNDRED AND 68/100 (PhP 114,510,100.68)**, inclusive of VAT and all other applicable government taxes, fees, and charges, being the Approved Budget for the Contract (ABC) **for the first year only**, to payments under contract for the bidding of **Manpower Services for Technical and Administrative Support for BCDA under a Three (3)-year service contract**, broken down as follows:

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 13 April 2023 (Thursday) in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, the BAC-G conducted the Pre-bid Conference on 20 April 2023 (Thursday) at 10:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City which was attended by two (2) prospective bidders, to wit:

- a. DBP Service Corporation; and
- b. Omniworx Inc.

WHEREAS, in response to said advertisements, two (2) bidders, **DBP Service Corporation (DBPSC) and Omniworx Inc.** submitted their bids for the project before the deadline on 03 May 2023 (Wednesday) at 10:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the 03 May 2023 (Wednesday) opening of bids at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G received and opened the bid from the above-mentioned bidders and noted the following:

WHEREAS, the Technical Working Group (TWG) conducted a detailed evaluation of the submitted Financial Proposals of the two eligible bidders and found out that **DBP Service Corporation** and **Omniworx Inc.** have the same bid of **ONE HUNDRED FOURTEEN MILLION FIVE HUNDRED TEN THOUSAND ONE HUNDRED AND 68/100 (Php 114,510,100.68)**, inclusive of Tax and all applicable government taxes and fees. Thus, the BAC-G declares **DBP Service Corporation** and **Omniworx Inc.** as the Lowest Calculated Bidders (LCB) for the project;

WHEREAS, pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of the bidders, **DBP Service Corporation** and **Omniworx Inc.** on 09-16 May 2023 to determine if **DBP Service Corporation** and **Omniworx Inc.** are compliant and responsive to the requirements and conditions specified in the Bidding Documents;

WHEREAS, based on the results of the post-qualification, the TWG found **DBP Service Corporation** and **Omniworx Inc.** compliant with and responsive to the eligibility, technical, and financial requirements of the project;

WHEREAS, the BAC-G declared to conduct a Tie Break Activity by inviting the authorized representatives from **DBP Service Corporation** and **Omniworx Inc.** to agree on a selection criteria which should be non-discretionary / non-discriminatory and similarly based on sheer luck or chance in compliance with the Government Procurement Policy Board (GPPB) Circular No. 06-2005, Section 3.3.;

WHEREAS, during the 22 May 2023 (Monday), a Tie-Breaking Activity was held at the BCDA Corporate Center, Bonifacio Global City, Taguig City, in the presence of the authorized representatives from **DBP Service Corporation** and **Omniworx Inc.** The bidders agreed to use "Toss Coin" as the method of the Tie Break Activity, in compliance with the Government Procurement Policy Board (GPPB) Circular No. 06-2005, Section 3.3.;

WHEREAS, the **DBP Service Corporation** was declared as the winner of the Tie-Breaking Activity, thus was declared by the BAC-G as the **Lowest Calculated and Responsive Bidder (LCRB)** for the Procurement of Manpower Services for Technical and Administrative Support for BCDA under a Three (3)-Year Service Contract;

1. To declare **DBP Service Corporation** as the **Lowest Calculated and Responsive Bidder (LCRB)** for the **Procurement of Manpower Services for Technical and Administrative Support for BCDA under a Three (3)-Year Service Contract**;

2. To award the contract to **DBP Service Corporation** with the amount of **ONE HUNDRED FOURTEEN MILLION FIVE HUNDRED TEN THOUSAND ONE HUNDRED AND 68/100 (PhP 114,510,100.68)**, inclusive of VAT and all applicable government taxes and fees; and
3. To direct the **Human Resources Management Department (HRMD)**, being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
