WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 15 November 2023 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 22 November 2023, which was attended by the following prospective bidders:

- a. CIM Technologies, Inc., and
- b. Ynzal Marketing Corporation

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-ITS-2023-01 dated 29 November 2023 clarifying the queries raised by the prospective bidders during the Pre-bid Conference, and subsequently via e-mail;

WHEREAS, in response to said advertisement, CIM Technologies, Inc. and Ynzal Marketing Corporation submitted their bids before the deadline on 06 December 2023;

WHEREAS, during the Opening of Bids on 06 December 2023 at 1:00 PM, BAC-G received and opened the bid documents of the two (2) bidders and noted the following:

Since the two (2) bidders are eligible and have passed the initial evaluation of the eligibility and technical requirements, their financial proposals were opened and BAC-G noted the following:

WHEREAS, in view of the results of the Detailed Evaluation of Bids on 11 December 2023, BAC-G has declared the bid of **CIM Technologies, Inc.** and **Ynzal Marketing Corporation** as eligible for Lot 1 and Lot 2, respectively;

WHEREAS, BAC-G recommended that CIM Technologies Inc. and Ynzal Marketing Corporation undergo a post qualification within the period 12-22 December 2023 pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found CIM Technologies Inc. and Ynzal Marketing Corporation as legally, technically, and financially eligible and capable to undertake the project;
