WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2023 Corporate Operating Budget (COB), applied the sum of **One Million One Hundred Seventy Thousand Pesos and 00/100 Only (Php1,170,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges as the Approved Budget for the Contract (ABC) for the **Rebidding of the Procurement of IT Equipment & Software for Lot 3 (Software)**, broken down as follows:

WHEREAS, on 16 November 2023, BAC-G, through its Secretariat, advertised the Invitation to Bid in the following platforms:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 28 November 2023 at 10:00 A.M. at the BCDA Corporate Center, Bonifacio Global City, Taguig City, which was attended by four (4) prospective bidders, namely:

1. Certeza Infosys Corp.
2. Ynzal Marketing Corp.
3. Infrasy, Inc.
4. CIM Technologies Inc.

WHEREAS, in response to said advertisements, CIM Technologies, Inc. is the sole bidder who submitted their bids before the deadline of submission of bids at 9:00 A.M. on 13 December 2023 (Wednesday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City.

WHEREAS, during the Opening of Bids on 13 December 2023 (Wednesday) at 10:00 A.M. at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G received and opened the bid from the above-mentioned bidder and noted the following:

WHEREAS, the financial envelope of CIM Technologies, Inc. who “passed” the preliminary examination of the eligibility and technical documents was opened and subjected to a preliminary evaluation by determining the presence or absence of the required financial documents using a “pass/fail” criterion.

WHEREAS, on 18 December 2023 to 18 December 2023, the BAC-G conducted a detailed evaluation of the bidding documents of the sole bidder and noted the following:

- a. The bid proposal submitted by the sole bidder was found to be compliant with the legal and technical requirements; and
- b. Based on the submitted financial bid, BAC-G declared **CIM Technologies, Inc.** as the Single Calculated Bidder (SCB) for the Rebidding of the Procurement of IT Equipment & Software for Lot 3 (Software).

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of **CIM Technologies, Inc.** during the period 21-28 December 2023 to determine if **CIM Technologies, Inc.** is legally, technically, and financially capable to undertake this project and responsive to all bidding requirements including the specification/terms of reference as stated in the bidding documents;

WHEREAS, in the 28 December 2023 meeting of the BAC-G, the BAC-G concurred with the TWG’s recommendation, confirming that **CIM Technologies, Inc.** is eligible, technically, and financially capable to undertake the project.

The Post-Qualification Report is hereby attached as “Annex D”.

ACCORDINGLY, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend the following:

1. To declare and recommend the award of contract to **CIM TECHNOLOGIES, INC.** as the Single Calculated and Responsive Bidder (SCRB) for the **Rebidding of the Procurement of IT Equipment & Software for Lot 3 (Software)** in the amount of **One Million Forty Thousand Pesos and 00/100 Only (Php1,040,000.00), inclusive of VAT and all applicable taxes and fees;** and
2. For the **Information and Communications Technology Department (ICTD)**, being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
